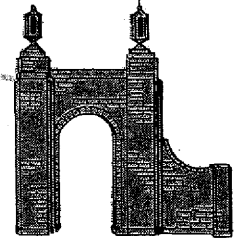

Dear Mrs Meagher wrote

I have not written you before this on account of my wife & myself being very ill since I saw you in October 1968 my wife has just died on Feb 12-1971 and I am left all alone now. I took sick as soon as I arrived in England and was pronounced dead twice with Cardiac Failure due to a "Wet Lung" I don't think I got a chance to write you. I was not getting any better & the doctors told me to go back home out of the cold wet weather. My wife had fell down on the ice the 1st of Jan & broke her right knee cap & couldn't walk up stairs. I managed to attend one college meeting for a lecture on the assassination on Nov 22 and then went into hospital.

The suppression on books that do not lick the Commission's boots was bad over there as here and The International Organization of Book stealers has cleaned out all books that do not say "Oswald did it alone" from the libraries and bookstores I put in an order with a firm that specializes in finding rare books all I got was the English Editions of "Who Killed Kennedy" and Rush to judgement. Martin Secker & Warburg said there was published on May 8-64. Putnam's won't tell me when their altered text version was published. There were 19 foreign editions

I have been able to read the French - Spanish + German eds
I am busy compiling an addendum supplement to my Bib
and would greatly appreciate it if you can give me the Bib
names of any new books that came out since I published my
I bought "Farewell America" I have "The Garrison Affair"
Report" - Books by Paris Flammarion - Newman - Curry - Judy Bonnet -
Whos Who in the CIA from Sherman H. Solnick (do you know
which critics he refers to, as wanting the Warren Report upheld
so they can write more books?) I have wrote him but he hasn't
replied. It took 2 months to get his 2nd copy of his Court Case vs
The archives. Who failed in a court case to get the autopsy
films released? I am in correspondence with SJ marks and
I managed to buy both editions at Coop d'Etat and he sent me
his last copy of the paperback ed with no back cover, of "Murder
most foul" - Have you the Hard Cover edition and also the
two editions of "Two days of Infamy"? He sent me the galley
proofs of it less 1 chapter and the photos. Have you a copy of
70 hours + 20 minutes? I have the later edition with photos in.
My Bib entry 102 + want to check the two, word for word.
I would like to Copy your Index on the Copying machine. I
will pay you for the loan of it + registered post both ways.
The Library wont send out a request on inter Library Loan for
they have a copy in their Research Dept + wont loan it out. Their
copying machine is not much good.
Can you complete the data on my entry No. 263?
I received the 10 reels of over 10,000 frame total of micro
film from Bell + Howell on the newspaper coverage from
Nov 21 through 29.
