## Warren Report To Dallas From

The white-haired little lady known the world over as the mother of Lee Harvey Oswald sat in her living room in Fort Worth the other night after supper and made a startling statement.

Holding an open volume of the famous Warren Commission Report in her lap, Mrs. Marguerite Oswald calmly looked her visitor in the eye and announced:

"According to Volume. 17 of the Warren Report, Governor Connally's wife was not in the car with him in Dallas when President Kennedy was shot."

Mrs. Connally," she declared, "was in Austin and flew to Dallas after the shooting. It says that right here on pages 470 and 471."

And . . . so it does!

The exact wording of that part of the Warren Report is printed below. It quotes a two-way police radio conversation which took place at 1:37 p.m. on Nov. 22, 1963. This was a little more than an hour after the president was shot.

The letters "Disp" mean "radio dispatcher" at police headquarters. The numbers 1, 2, and 39 refer to police patrol cars which were talking with the dispatcher.

Ther term "Dallas 1" refers to the car driven by Dallas County Sheriff Bill Decker. Car No. 1 was occupied that day by Dallas Police Chief Jeff Curry, since retired.

Car No. 2 was occupied by Charles Batchelor, then assistant chief, now the chief of the Dallas police. The occupant of car No. 39 is not identified.

## s Mrs. John Connally Flew Austin After Assassi

DISP: 1 or Dallas 1 -when we get to main entrance. . are you onroute to Love Field?

(Car) 1 -- Yes, but don't put it on the air. 1:37 p.m.

(Car) 39 -- I got a state unit going South-west Airmotive to pick up . . .

(Car) 2 -- We have information that someone to pick governor's wife

(Car) 1 -- Don't let any cars follow us into the field.

DISP: -- 10-4

(Car) 2 -- Mrs. Connally is being flown in here from Austin. She will arrive at Love Field. A state car will be standing by but will probably be an hour before it gets here. Notify Command Post at Parkland to get through when she/arrives.

DISP:-- 10-4 DISP? -- Mrs. Connally

will arrive in about an hour. Be sure to let her through.

Mrs. Oswald said:

"I reason that Mrs. Connally cannot be with the governor during the assissination and in Austin at the same time. It is my belief that the woman in the presidential car with the governor was not his wife but a woman made up to look like her."

Dallas police inspector J. Herbert Sawyer, who testified before the Warren Commission, said last week he wasn't at the airport and didn't know if the governor's wife flew in from Austin or not.

"I'm not saying this is a conflict in the police reports," said Sawyer, "because I don't know if Mrs. Connally was with the governor or not during the assissina-tion."

Reminded that witnesses testified Mrs. Connally was in the presidential car at the assassination, Sawyer replied, "You said that ...
I didn't!"

Dallas police chief Batchelor said last week he didn't know if the governor's wife was with him during the assassination or not because he was at the Dallas Trade Mart awaiting the arrival of President Kennedy.

"I'm not going to comment on the issue any more," the chief said. "As far as I am concerned, the Warren Report is a closed case."

Batchelor refused to answer questions about whether the police report was mistaken about Mrs. Connally flying in from Austin.

Larry Temple, an aide to Gov. Connally in Austin, said last week he had

not seen the police log in the Warren Report. But he added that it was a mistake if it said Mrs. Connally flew from Austin after the assassina-

"Mrs. Connally was with the governor from the moment he was shot until he began to recover at Parkland Memorial Hospital in Dallas, Temple said. "All I can say is that this is an error."

Temple said the only members of the governor's family to fly to Dallas on the day of the assassination was Mr. and Mrs. Merl Connally, the governor's brother and sister-in-law.

"The governor's brother and wife arrived in Dallas late on the night of the assassination, therefore, it couldn't have been them mentioned in the police report at 1:37 p.m.," Temple concluded.


