Dear Sue

In Friday's paper there was an article along with news of THE CASE with the questioning and wondering out loud where the money for the organization Clay Shaw was representing came from. I will translate the article and any others that might be of interest to you and sylvia and send them along when I get some time and organization in my bones. In essence the article says:
