

Roberts says that the autopsy report on President Kennedy was written by "the best-qualified team of forensic-medicine experts the U.S. Navy could muster." He is incorrect. Commanders Boswell and Humes of the Navy are not forensic pathologists; Colonel Finck of the Army is a qualified forensic pathologist, but he arrived when the autopsy examination was already in progress and at an unspecified stage.

It is the Warren report that is on trial, not Edward Jay Epstein's "Inquest" or any other critical work. And thus far, the case for the defense of the report-to cite but one example—is pitifully feeble, and often inaccurate as to basic facts.

But if she implies that the three-man board was incompetent to conduct the autopsy and resolve questions of forensic (legal) medicine, then she is at variance with the professional opinion of Dr. Benwood Hunter, president-elect of the College of American Pathologists (and himself a certified forensic patholo-

"Turned-on Way of Life" emphasizes only the "kicks" side of the modern world's rampant abuse of chemicals (MEDICINE, Nov. 28). For many the motive is more serious: to discover hidden realities in life and to develop new and transforming psychological insights. Here the problem is far more insidious. Many advocates of LSD and other hallucinogens are convinced that the drugs are valid and effective tools for expanding consciousness, and a drug-god religion has even been founded on that premise. Psychedelic visions and experiences are often compared with higher states of consciousness described in Eastern mystical literature.


Actual authorities on the Eastern side have an explicitly different view. India's eminent spiritual master Avatar Mehar Baba has pointed out that even the authentic spiritual experiences and trance states of advanced yogis are "as toys for children" compared to the uninterrupted experience of oneness with God, which is real and final enlightenment. "If drugs could make one realize God, then God is not worthy of being God. These drugsfrom marijuana to LSD-are harmful physically, mentally and spiritually ... Love others, make others happy, serve others even at discomfort to yourselfthis is to love God and the way to find your Real Self."
