KCOP, ABC FLOODED WITH LETTERS, PHONE CALLS Public response to assassination film overwhelming, support needed for Congressional investigation tests for determining a group of

That was the week that was. The week the American public, on a mass scale, was finally able to view the infamous Zapruder film that depicts the assassination of President John F. Kennedy.

Free Press (March 7) and on two TV shows, Mort Sahl's (Both Sides Now - KCOP) and Geraldo Rivera's (Goodnight America - ABC), the brief 8mm film - taken by Dallas clothingmaker Abraham Zapruder as the presidential caravan moved through Dallas' Dealey Plaza on Nov. 22, 1963 - shatters once and for all the Warren Commission contention that President Kennedy was fatally shot from behind by a lone assassin.

The film, purchased by Time, Inc. immediately following the assassination, was never widely shown to the public until last week. It shows unmistakeably that the fatal shot which tore the president's head apart was a frontal attack - a direct visual denial of the Warren Commission findings!

Angry/Shocked Response

Comedian-researcher Dick Gregory posed the following question to the Free Press after a recent showing of the film: What happens when the mass of the people see this film? That question was answered last week when ABC and KCOP aired it and hundreds of thousands of Americans had front-row seats. Since then, both the ABC network and KCOP have been flooded with telegrams, letters and phone calls commending the stations for having the courage to put the evidence on the air and ask-

ing the vital question: who really killed JFK?

Los Angeles independent TV station KCOP aired the Zapruder film Wednesday night (March 5) and the following morning the response was so As reported in last week's overwhelming that an additional die the telephone calls. Viewers, both grateful and irate, have to date sent in several sacks of mail, eliciting from Both Sides Now production assistant Shelby Livingston this com-ment: "An exceptional reaction - by far the most and best response we've had to any show." According to Livingston, most callers asked how to go about demanding an official investigation of the assassination.

At ABC network headquarters in New York, Goodnight America associate producer Elene Berg termed the response to the Thursday night showing of the Zapruder film "astonishing." Like KCOP's report of viewer-reaction, Berg says the showing of the film has resulted in "the most response of any show to date; we've had calls from all over the country.

Calls and letters have been so heavy at ABC that the network decided to devote the next Goodnight America program, airing March 27, entirely to the assassination of John F. Kennedy and the coverup by the Warren Commission.

More Coverup

It is curious that much of the evidence sought by investigators attempting to unravel the true facts of the JFK assassination has been buried in the national archives for the past 11 years.Among the most important of those suppressed

two chemical tests, respectively known as "spectographic analysis" and "neutron activation analysis," analyzing the exact composition of bullets by ballistics experts.

(Ironically, the Freedom of Inlone assassin. formation Act, which Weisberg is using in an attempt to gain access to the potentially damning evidence, was just recently passed - despite the veto by President Gerald Ford, who as a Warren Commission member was among the most vocal supporters of the lone-gunman theory.)

Congress Has The Ball

The overwhelming response by an outraged public to the Zapruder film comes at a time when Congress is being asked to reopen the assassination investigations of the Kennedy brothers, Martin Luther King and the near-assassination of George Wallace.

Congressperson Henry Gonzalez, D-Tex., has introduced a resolution (H.R. 204) in the U.S. House of Representatives asking that a select committee be appointed to conduct an investigation and study the circumstances surrounding the

assassinations (see Free Press March 7 for details of Gonzalez resolution).

What Can You Do? The Gonzalez resolution has been referred to the House Committee on Rules, whose chairperson is Rep. Ray Madden, D. Ind. Gonzalez has appealed to "all concerned citizens" to write Madden and their own Congresspersons demanding that an early hearing be held and that an official investigation be undertaken.
