Dear Cyril,

As we discussed this afternoon, I am enclosing a list of critics who, I believe, would be interested in attending the November 1988 program.

In due time, when you notify them about the program, you might wish to ask each one for additional names, and for suggestions about the subjects that might be covered.

The whole idea is exciting and, as I said on the phone, I would like very much to accept your invitation to participate—preferably in a modest capacity—if health permits.

Off the top of my head, a few topics occur to me: A discussion of the official investigations and what was wrong with them; the role of the news media; the indications of conspiracy; evidence tending to exonerate Oswald; the autopsy and medical findings; what does the Zapruder film tell us; the acoustical evidence of the HSCA; and the role of the official agencies (Dallas police, FBI, CIA, etc.).

These are all subjects which have already been thoroughly treated in the literature, radio programs, and other public forums. I wish I could come up with some new slant but none comes to mind at the moment. I am sure that you will be getting good inputs from other people and there is plenty of time for preparation.

We are all in your debt for organizing such a program.
