

~~Confidential informant~~ Dallas T-6 on December 2, 1963 furnished the following:

T-6 could identify his initials on Form IB-1, for LEE HARVEY OSWALD, and Forms IB-14 and IB-2. He stated that according to these records, OSWALD came to his office personally on April 29, 1963; May 7, 1963; May 15, 1963; July 30, 1963; August 27, 1963; and September 3, 1963, to execute these forms. He stated that when the claimant appears at the office he is required to sign the form he is presenting in the presence of the claims interviewer, at which time the claims interviewer checks the signature against the original known signature of the claimant appearing on Form IB-1. He stated that in the weekly submission of Form IB-2 the claimant usually presents this form executed with the exception of his signature, which he also signs in the presence of the claims interviewer and is checked as described above. Dallas T-6 stated that he could identify the photograph of LEE HARVEY OSWALD as the same individual whose claims he handled in New Orleans on the dates indicated above. He stated that he recognized OSWALD from television appearances in latter November, 1963, as the same person he had waited on previously.

On December 2, 1963, Dallas confidential informant T-3 furnished the following information:

According to the Form IB-1 in the name of LEE HARVEY OSWALD, which is a claim record card, he had personally waited on OSWALD on August 13, 1963; August 20, 1963; September 10, 1963; September 17, 1963; and September 24, 1963, on which dates OSWALD presented to him a Form IB-2 which is a continued interstate claim. He stated that the usual procedure, and he is certain this was followed in this case, was for the claimant to furnish the executed form with the exception of the signature and at the time the form is presented the claimant would sign it in the presence of the claims interviewer who would then check the signature against the known signature of the claimant appearing on Form IB-1.



Dallas T-3 stated that when he saw OSWALD's picture on television and in the newspapers in connection with the assassination of President KENNEDY, he did not recognize him as being the same individual he had come in contact with as noted above. He did state, however, that he could identify the photograph of OSWALD shown to him on December 2, 1963, as being identical with the person he contacted on business as shown above.

On December 2, 1963, confidential informant Dallas T-2 advised as follows:

According to the Form IB-1, a claim record card in the name of LEE HARVEY OSWALD, he did on August 6, 1963, handle a Form IB-2 furnished by OSWALD on his weekly personal appearances at the office for his unemployment insurance claim. Dallas T-2 stated that on each occasion the claimant submits the executed form, which he signs in the presence of the claims interviewer to verify the signature from the IB-1 card. He stated that at the time this form is presented by the claimant, the claims interviewer notes the date and type of form submitted on the IB-1 card, as well as on the claimant's identification booklet. The claimant usually obtains a blank IB-2 form, which he executes for the next appearance the following week.

Dallas T-2 stated that he did not recognize the pictures of OSWALD on television and in the newspapers in connection with the assassination of President KENNEDY as the same person he had waited on; nor could he identify a photograph of OSWALD displayed to him on December 2, 1963, as this person.



Confidential Informant Dallas T-7 furnished the following on December 2, 1963:

He advised that any claimant registering in his office would have had to identify himself with some document showing his name, date of birth, and Social Security number; however, he could not recall specifically what documents LEE H. OSWALD presented on April 26, 1963, at which time he executed Form LSES-511.

He stated that he did recall that while OSWALD was in his office and upon learning that he was a photographer, he telephonically contacted the George Reppel Studio, 5220 Elysian Fields, to determine if they needed the services of a photographer. Upon learning that they needed a photographer, he directed OSWALD to report to that company for possible employment. A few days later he re-contacted the studio and learned that OSWALD had never appeared there.

Dallas T-7 stated that the handprinting contained on LSES-511 Form is entirely in OSWALD's hand printing, with the exception of three lines which Dallas T-7 wrote in the block entitled, Skills, Knowledge, Abilities, and except for the notations written by Dallas T-7 on the reverse side of the card in the block entitled, Special Information and Employment Counseling Statement. Dallas T-7 stated also that in the upper right hand corner of the reverse side of the card, he personally wrote the letters, R. I. F., which was his way of flagging the reason for OSWALD's leaving his last employment as a reduction in force.

He stated that this form further reflected that on April 29, 1963, OSWALD reported to their office on Camp Street, and that on July 22, 1963, he reported to their office on Canal Street, at which time he apparently gave a change of address as was noted in block #2 and re-activated his claim.

He stated that he could not identify OSWALD from a photograph displayed to him, but did recall that when he first saw OSWALD's photograph on television in late November, 1963, he recognized him as being the same person he had dealt with previously.

Dallas T-7 stated that when OSWALD reported to their Camp Street Office, his identification booklet furnished to him on April 26, 1963, should have been taken up and a new booklet called Claimant's Identification Booklet should have been issued to him in which his weekly appearances are noted. He stated that inasmuch as OSWALD was an interstate claimant and the libel state was Texas, then his weekly appearances would be furnished to the Texas Employment Commission, Austin, Texas, who would then issue an unemployment check and which would be mailed directly to OSWALD. The weekly appearances of OSWALD were recorded by Form IB-2.
