Mrs. GRACE CRANER, 3124 West 5th Street, advised that she is a public school teacher and cwns the property at this address.

Mrs. CRANER stated that Mrs. MARGARITE OSWALD rented a two-room apartment from her, located at the rear of this address, during the summer of 1959, exact dates not recalled. However, she said that Mrs. OSWALD was in the apartment for about two to three months.

Mrs. CRANER said that at one time during the period Mrs. OSWALD was in the apartment, that she recalls this person telling her that her son, a LEE OSWALD, had just arrived in town after being discharged from the Marine Corps and asked Mrs. CRANER if it would be possible for her son to stay a few days in the apartment with her. Mrs. CRANER said that she had a roll-away bed placed in Mrs. OSWALD's apartment for the son. Mrs. CRANER said Mrs. OSWALD told her at that time that she would like for her to meet hor son, as he was only going to be in town for a few days.

Mrs. CRANER stated that she never did meet the son, and in about a week after placing the roll-away bed in the apartment, Mrs. OSWALD told her that her son had already left and had gone to New Orleans, Louisiana. Mrs. CRANER said Mrs. OSWALD did not give any reason for her son going to New Orleans.

Mrs. CRANER said further that during the period of time Mrs. OSWALD lived at this apartment, that she was unemployed; however, she always paid her rent. She was involved in some type of compensation suit concerning an injury she had received while employed at a candy company.

Mrs. CRANER said further that the only contact she has had with Mrs. OSWALD sines Mrs. OSWALD moved from this apartment was one day after the news of her son going to Russia, Mrs. OSWALD called and asked if she had any mail at this address.

Mrs. CRANER said she had no further information concerning Mrs. OSWALD other than during the period of time one resided at this address, Mrs. OSWALD told her she also had a son living in the Ridgelea Section of Fort Worth, and Mrs. CRANER also believes Mrs. OSWALD said she had another son in the armed forces.

Mrs. CRANER advised that she had no information concerning LEE CSWALD and did not actually see this person during the time he stayed in the apartment with his mother, which would have been less than one week.

MORTON N. GOLDBERG, M.D., 711 W-T Waggoner Building, advised he desired to furnish some information he thought may be of some benefit concerning the assassination of President KENNEDY.

Dr. GOLDBERG said he formerly had a patient, a Mrs. MARGARET OSWALD, 3006 Bristol Road. Dr. GOLDBERG advised his records reflect the following information concerning MARGARET OSWALD:

April 4, 1957 - Was seen for a general checkup Diagnosis: Stress - reason unknown.

November 11, 1957 - Colon X-ray.

January 9, 1959 - Patient for injuries due to a candy box falling on nose in December, 1958. Dr. GOLDBERG said that on this visit he could not find anything except a bruised nose. Patient was sent to Dr. SKOKAN who in turn send her to Dr. HARRIS, an eye, ear, nose, and throat specialist, where hot packs were put to the nose and it began to drain pus on the right side.

January 30, 1959 - On visit, small piece of skin came out of nose.

Dr. GOLDBERG said that at the time Mrs. OSWALD was employed by the King Candy Company however that he could not go along with the alleged injury for compensation purposes which allegedly happened at the King Candy Company.

Dr. GOLDBERG stated he recalls during the period of time he treated MARGARET OSWALD that she told him her son, name not mentioned, wanted to defect to Russia. Dr. GOLDBERG said he recalls further MARGARET OSWALD also telling him that this son had beaten her on several occasions. Dr. GOLDBERG said he did not know this son.

Dr. GOLDBERG advised he had no further information at this time however said that his medical records concerning HARGARET GBWALD would be made available at any time upon request and said the reason he contacted the FBI was he felt the above information should be brought to the attention of the FBI.
