ReBuairtel to NY dated 6/14/62, requested NYO to contact INS, NYC, and verify subject's arrival in US and determine his destination.

On 6/22/62, Mr. ALISTAIR MC DONALD, Assistant Manager, Cabin-Tourist Department, Holland-America Line, 29 Broadway, NYC, advised SA CHARLES T. WEIS that the records of Holland America Line reflect that one L. OSWALD, wife and child arrived in the US on 6/13/62, aboard the SS MAASDAM at Hoboken, NJ. They traveled tourist class and were destined to 7313 Davanport St., FortWorth, Texas.

On 6/22/62, the records of INS, 20 W. Broadway, NYC, were reviewed by SA WILLIAM F. MARTIN on LEE HARVEY OSWALD who is subject of INS file A 12 386 726. The file reflects that an emergency lookout was placed on OSWALD on 5/4/62. LEE H. OSWALD, US passport 1733242, his daughter JUNE, born 2/15/62, Minsk, USSR, same US passport number and his wife, MARINA NIKOLAEVNA OSWALD, Russian passport KY 37790, arrived in the US aboard the SS MAASDAM on 6/13/62. OSWALD was admitted as a US citizen with a renewed US passport. MARINA NIKOLAEVNA OSWALD was admitted with an M-1 (Immigrant Visa) (Spouse of US citizen) issued in Moscow on 5/24/62. Her file could be located at INS, 1100 Main St., Dallas, Texas. OSWALD and family were destined to 7313 Davanport, Fort Worth, Texas.

INS Inspector FREDERICK J. WIEDERSHEIM advised SA MARTIN that he interviewed OSWALD upon his arrival in the US. OSWALD told WIEDERSHEIM that he was employed as a mechanic in Russia, threatened to renounce his US citizenship but never carried through with the threat, never voted in Russia and held no position in the Russian Government.
