"The Oswald Case: Who Wants the Truth Kept Down?" pages 1-2, on Mrs. Marina Oswald's appearance before Warren Commission; quotes Justice Warren statement to AP and reporters that "Mrs. Oswald's testimony many not be released in your lifetime" and that it may "involve matters of national security." Article refers to widespread rumours that Oswald may have been FBI or CIA agent and says if so, national security would be ill-served by suppression of that information.

NEW YORK TIMES 11 February 1964

TIME 14 February 1964

Hidell", purchase of rifle, attempted shooting Gen.
