## All but 5 of 39 Victims of Rioting Were Negroes

The authorities say that 19 of the 39 persons killed in the violence after the murder of the Rev. Dr. Martin Luther King Jr. were either shot while they were looting or died as a result of fires.

All but five of the 39 were Negroes. Four victims were females. Fifteen of the dead were 21 years of age or under, including an 11-month-old baby who burned to death in his crib in Chicago.

Of the total, 25 persons died of gunshot wounds, 10 died as a result of fires and four died of other causes, according to a survey by The Associated Press.

Eleven persons died in Chi-

cago, seven in Washington, six each in Baltimore and Kansas City, two each in Cincinnati and the Detroit area and one each in Memphis, Minneapolis, Tallahassee, Trenton and Jacksonville.

Police gunfire accounted for 11 of the gunshot victims, nine were shot by unknown persons and five were shot by private citizens.

No deaths were specifically attributed to National Guard action.

### CHICAGO

The Chicago authorities gave the following case-by-case breakdown on the 11 deaths there, all the victims being Negroes:

Curtis Jefro, 31 years old, a die caster, lived in a housing

project. He went out on his 12th-floor balcony to observe a disturbance last Saturday. He was found dead of a wound that the police attributed to a stray bullet.

Marvin Carter, 24, married with three children, was to have started a new job Monday. He left home April 5 around 5 P.M. Four hours later the police saw some men carrying merchandise from a South Side store. They fired and Mr. Carter fell dead in an alley.

Robert T. Dorsey, 31, a truck driver, and his wife were walking home April 5 when shots rang out on the West Side. Mr. Dorsey pushed his wife to the ground, then fell, moaning. "They got me. They shot me in my back."

Clayton Webb Jr., 27, a meat packing plant employe, went out April 5 in his bedroom slippers to get some beer. Several hours later the police found him shot to death in a South Side alley. How he was shot is unknown.

### 'On Top of the World'

Willie McMullin, 21, had been in Chicago a year. He worked in a meat packing company. "Two weeks ago he got a better job at a steel mill in Gary," a cousin said. "He was on top of the world." Mr. McMullin was found dead April 5 of smoke inhalation in a looted, destroyed grocery store on the West Side.

Ponowel Holloway, 16, was shot and killed by the police while he was looting a store on the West Side. He was a sophomore at Marshall High School.

Cyrus Hatfield, 32, left McClain, Miss., in 1955. His wife and five children were living there, waiting for him to return. His body was found in the ruins of a women's apparel shop that had been looted and set on fire. A bullet was in his chest.

John Sandifer, 24, bled to death in a gutter on Roosevelt Road, apparently from a huge gash in his knee. The police said he might have been a looter who cut himself on a broken window in a looted store.

Paul Evans, 22, was shot to death April 5 inside a burned-out store on the West Side.

Everett Austin, 11 months, was found burned to death in his crib in a third-floor apartment on the West Side. The fire had apparently been set. Mrs. Austin was playing cards in a nearby apartment. "There

was no way I could get to my baby," she said.

Mrs. Barbara Walker, 25, was shot and killed by her brother, Oscar King, 27, while they were driving on the Kennedy Expressway. The Cook County coroner, Andrew J. Toman, attributed Mrs. Walker's death to the rioting because he said her brother had been worked into a frenzy by the disturbances.

Only Mr. Holloway and Mr. Carter were shot by the police during looting. The other shooting fatalities are still under investigation.

The police said Mrs. Walker's death and the death of 11-month-old Everett Austin were not related to the violence. The coroner, however, contended they were.

### WASHINGTON

Thomas S. Williams, 15, Negro, a junior high school student, was accidentally shot by a white policeman who had stopped some fleeing looters, the police say. A witness says the policeman's gun was not drawn when young Williams ran by and bumped him.

Ernest McIntyre, 20, a Negro janitor, was looting a liquor store when shot by a policeman, the police say.

Harold Bentley, 34, a Negro construction worker, was killed when a wall of a smoldering brick building collapsed on him.

An unidentified Negro boy, about 14, was found dead in the charred ruins of a variety store.

George W. Neely, 18, Negro, a junior at a vocational school, was also found dead in the store's ruins.

A Negro man, about 40, known only as "Red Rooster," died of smoke inhalation. He was a cart pusher in the slum district and collected soft drink bottles for resale. His body was found in the rubble of a burned-out market.

Annie Mae James, 52, a Negro who weighed 420 pounds and had difficulty getting around after a fall last summer, died in a hospital of smoke inhalation. She lived above a clothing store that was burned. Her two sons, with help, got her down the stairs. According to her son, Clarence, 36, she said she was dying and wanted to see her friends. He drove her and other relatives around to see friends, traversing the area of burning buildings and milling crowds, and then took her to the hospital.

### BALTIMORE

Lee Albright, white, was found dead in burned-out supermarket. He died of carbon monoxide poisoning. It was unknown whether he had been looting.

An unidentified Negro man was found dead at the same fire. He died of the same cause. It was not known whether he had been looting.

Napoleon K. Slay, 37, a Negro, was shot and killed by the Negro night manager of a bar after he allegedly began exhorting other patrons to loot the bar.

William V. Stepter, 47, a Negro, was shot by a city policeman as he ran from a tavern. The police listed him as a looter.

Caddy Hudson, a Negro man, was found dead by firemen in a burned-out building.

Lois T. Majette, 20, white, was killed when a car driven by her husband, Arthur L. Majette, struck a police car driving through unruly crowds early Sunday.

### KANSAS CITY

The police gave the following account of the victims, all of whom were Negro:

Maynard O. Gough, 30, was shot by the police while, they

said, he was looting a liquor store.

The Rev. George E. McKinney, 50, was shot by an unknown person while crossing the street near his home.

George E. McKinney Jr., 16, son of Mr. McKinney, was also shot by an unknown person while crossing the street.

Charles S. Martin, 43, was shot by an unknown person in an area of sniper fire.

Julius P. Hamilton, 38, was shot by an unknown person in a sniper area. His family contends he was shot by the police while standing in the doorway of friend's home when the police tried to evacuate the building.

Albert D. Miller, 21, was shot by the police in a gunfight.

### CINCINNATI

Noel Wright, 30, a white graduate student and art instructor at the University of Cincinnati, was attacked by a group of Negro youths and stabbed to death when he stopped his car after it was hit by a rock. His wife was beaten. Three young men have been charged with first-degree murder, two juveniles with assault with a deadly weapon.

Hattie Mae Johnson, 36, a Negro, was struck by a shotgun blast fired by her common-law husband, who said he was using the weapon to guard a jewelry store, the police said. He was charged with manslaughter.

### DETROIT

The police said that Eugene Alphonzo Gooch, 18, a Negro, was shot by the police while "fleeing from breaking and entering."

### HIGHLAND PARK, MICH.

The police said that Robert Vaughn, 18, a Negro, was being searched along with some other youths suspected of looting when he backed up into the drawn gun of a white policeman and the gun accidentally discharged.

### MEMPHIS

The police said that Ellis Tate, 40, a Negro, was shot by the police during looting. They said he tried to fire on them first with a rifle, which jammed.

### TRENTON

The police said that Harlan M. Joseph, 19, a Negro sophomore at Lincoln University in Pennsylvania, was shot by a white patrolman as he was being arrested in connection with alleged looting. The shooting occurred as a crowd went to the victim's aid.

### TALLAHASSEE, FLA.

The police said that Travis E. Crow 3d, 19, a white freshman at Tallahassee Junior College, died of asphyxiation. The death was ruled homicide by arson after a policeman said he had seen a fire bomb thrown into the building where the family was sleeping.

### JACKSONVILLE, FLA.

Rudolph Hargett, 18, a Negro, home on leave after Air Force basic training, was killed by a shot from a passing car filled with white youths, according to the police.

### MINNEAPOLIS

James F. Murray, 25, a white management trainee, was shot as he walked near his home. The police arrested Clarence C. Underwood, 27, a Negro, and charged him with first-degree murder. Detectives said Mr. Underwood's wife had told them he left the house after Dr. King's death, saying, "My king is dead. I'm going out and get me a honkie."
