Almost immediately after the assassination of President Kennedy and the subsequent murder of the alleged assassin, Lee Harvey Oswald, a rash of irresponsible and sensational books and articles appeared, all directed to the point that Oswald might well have been part of a larger conspiracy and indeed might not have committeed the deed at all.

A great many readers who were disgusted by these shoddy attempts to cash in on a national tragedy may be tempted to avoid these two new books dealing with the Warren Commission's investigation of the tragic events of November, 1963. This would be too bad, because both of these well-documented studies are deserving of serious attention.
