Mark Lane and/or Epstein/Sauvage/Weisberg/Lane reviews

- 8/13/66 Chicago Daily News, "Disturbing Attack on the WC," review of R to J by James R. Thompson (professor of law, Northwestern)...mixed bag of compliments and criticisms...says that WC did not do a complete job, WR has holes; but Lane also guilty "of attempting to rush us...in a manner which may strike one on first impression as sound and articulate, later as clever, and, on close analysis, and in some instances, as downright dishonest....Lane's book...reminds one of a sly summation of the defense side of a criminal case..." Says Lane's strong points include the Brennan/Rowland matters, though feels Lane has not been completely honest in his presentation of the facts about their testimony...Concludes (1) that the American people are entitled to a true critique of the WR which they have not yet had; R to J while doubt-provoking is inadequate and in many instances unfair; (2) that we are also entitled to an answer to R to J on the part of the WC, its individual members, or its defenders. "This answer, at least, should be immediately forthcoming to reaffirm the integrity of the commission and its conclusions. The doubts raised by R to J may be spurious, they may be dishonest, but while the book is here and the answer is not, they will stand."

(among them Weisberg, per Slusser, which is not accurate)...Considers Lane's book "an impressive legal defense of Oswald...covering the same ground as Weisberg and (in part) Epstein, but enriched by far greater detail"...Finds Sauvage's book "far less analytical" than Lane or Weisberg, "a lively newspaperman's account...particularly good in describing the development of the case..." Criticizes ML/HW/LS for treatment of the General Walker shooting and of Marina's credibility. Concludes, on balance, the critics were more successful in their efforts to discredit the WC than in providing an alternative solution..."in particular they have so far failed completely in their efforts to separate Oswald from the assassination..." Asks, where do we go from here? "The work of the WC...seriously flawed" but doubts value of suggestions that WC should reply to its critics or that a new investigation should be undertaken--"The search for the truth from here on can best be left to private initiative --to amateur detectives, lawyers, newspapermen, or scholars..."

PRESS CLIPPINGS RECEIVED 8/26/66

Daily Times Chester Pa. column by McCormick, states that the case against the WC is growing; difficult to imagine that persons in high places will not soon begin to demand an explanation from the U.S. Government; Fonzi article in Greater Philadelphia shows Specter unable convincingly to defend WR; if there is one man who could explain away the challenges to the WC's work it is Specter and he cannot; the interview with Specter shows clearly the WC guilty of the major charge being made against it; this thing is getting too much publicity to long remain quiet issue; "The W.C., whether through a massive blunder or intentionally, has not explained the death of an American President."

refers to "skewered cadaver of the Commission's report"...R to J a compelling powerful impassioned plea in behalf of the unvarnished truth, however appalling..."  
8/23/66 Boston Christian Science Monitor, review of R to J by Donovan Richardson, finds book very disquieting, says major questions raised by critics can and should be resolved. So far exposure of the conflicting autopsy reports has drawn from FBI only a tardy and unsatisfactory explanation. Fuller franker answers should be made by someone representing the WC.

8/24/66 Chicago Defender, Harry Golden column, ridicules books challenging WR in particular Lane Epstein Weisberg & Jean Stafford books

8/27/66 NYTimes story by Homer Bigart, "Pressure Denied on Kennedy Book," discusses Manchester's book, cuts made for reasons of taste and national interest

8/29/66 National Observer, WashDC, review by Jerrold K. Footlick of Lane, Epstein, Fox and Sauvage books, prefers Epstein and Sauvage books, but concludes WR still stands.
