Our relative newness or isolation may account for the space Forum devotes to Garrison. Whether there is any substance to Garrison's doings or not, it seems to be what's happening. By the way, Epstein's article mentions that Oswald attended the Powers trial in Moscow. I find this puzzling, since it is the first such assertion I know of that was not bald speculation. If I remember correctly, the audience at the trial was there by invitation only, and was composed almost entirely of CPSU apparatchiks who could be expected to hiss the villain.

Thank you again, and 1 hope to hear from you. I feel that the critics have so much in common, regardless of differences, that despite one's opinion of Garrison, cooperation is still possible and desirable.
