My primary expertise and involvement relates to the Robert Kennedy assassination, on which I've worked with Allard K. Lowenstein, Paul Schrade and others. Although the fact is little appreciated, the central incoherencies of the official theory of the RFK case are monumental and increasing. A police coverup has long persisted in Los Angeles, but can be overcome. Irresponsible work on the case merely aids the authorities; responsible, methodical and focused efforts can win substantial disclosure and force an honest reinvestigation.
