

Your question seems to presuppose the sighting of a common object. Neglecting the fact ## of the UFO having indeed become a very common object, I would say that if the phenomenon had appeared to be anything less common than a UFO I wouldn't be spending time on this report. I would instead be putting up shelves out in the garage.

The USAF Pretended Skepticism is infuriating. The supreme irony of this: that even today, after a generation of sharply increased UFO activity, countiess capable, fertile, ingenious and productive minds are wastefully diverted from any attention to UFO phenemena through naive faith that our military would be the first to declare UFO possibility if it were indeed a fact. It should not be thought that this naivete is an efficient automatic weeding-out process, and if this is your assumption then it can be an error of enormously grave consequences. Political or social or worldly naivete can not be correlated properly with special scientific talents. Is is an incontestable fact that those major develop ments in science which were not arrived at by evolutionary or brute-force or accidental means were born through momentary inspiration - and that a necessary condition for the inspiration was, obviously, freedom from conviction beforehand that a solution was either impossible or unneeded.

Your apparent notion that you already have the best heads in the country working on this (albeit for twenty unispired years) and that you can well do without any suggestions from those dunderhead muisances who would otherwise plague you but for their being weeded out through this idiotic process is as fine an example as can be found of "tossing the baby out with the bath water". I call this your "apparent" notion, though certainly you have never given any hint, publicly, that it is so. But, perhaps through having a need or preference or desire to believe that we are not all held in control by Brass Children, I choose the notion I hold on the basis of its being the least idiotic of all conceivable idiocies. As an article of faith in the USAF this is a peculiar compliment, but surely a compliment in view of my disbelieving your publi cized opinions: I do in a sense believe you know what you are doing, but charge you with the indefensible arrogance of presuming that your clique of workmen, who have been laboring now for twenty long years, have been chosen by yourselves and therefore must be the # best possible choice.

Allowing for an avalanche of invalid ideas and some \$50 million a year to consider and reject them, but in view of the enormous implications of the solved problems and the tremendously increased possibility of their being solved by some of our many millions who may not be in your present coterie, reason does not permit your exclusion of those people through your maintaining their faith that no problems of a UFO nature exist.

DEAR SIRS:

AT ABOUT MADE THIS MORNING I WAS AWAKENED BY WATCH OFFICER DONALD ROMINGER, ALERTING ME TO A UFO SIGHTING. MR ROMINGER HAD PREVIOUSLY NOTICED A COPY OF THE UFO INVESTIGATOR IN THE RADIOROOM AND HAD INFERRED FROM THAT MY INTEREST IN UFO'S.

ABOUT FIVE HOURS EARLIER I HAD COMPLETED RE-READING THE LAST THREE ISSUES OF THE UFO INVESTIGATOR, INCLUDING THE ACCOUNT OF THE 16 DEC 65 SIGHTING BY THE BRITISH S/S CARL SCHMEDEMAN, HAVING THUS GOME TO SLEEP WITH THE SCHMEDEMAN INCIDENT REFRESHED IN MY MIND AND HAVING BEEN AWAKENED TO WITNESS A SIMILAR SIGHTING A SHORT TIME LATER, I BELIEVE I MAY FOR THAT REASON HAVE NOTICED A CERTAIN CHARACTERISTIC OF THE "SCHMEDELMAN CLOUD" WHICH I MIGHT NOT OTHERWISE HAVE NOTICED IN THE EXCITEMENT OF THIS FIRST SIGHTING.

BY THE TIME OF MY ARRIVAL ON THE BRIDGE, THE CLOUD HAD GROWN TO THE APPARENT SIZE OF A GOLF BALL HELD AT ARM'S LENGTH AND WAS MOVING EITHER UPWARD OR TOWARD THE SHIP OR BOTH. ITS POSITION AT THAT TIME WAS APPROXIMATELY DEAD ANEAD (SHIP HEADED ABOUT DUE EAST) WITH AN ELEVATION OF PERHAPS TEN DECREES. FROM THAT TIME UNTIL THE CLOUD BECAME TEMPORARILY OBSCURED BY A "REAL" CLOUD SOME FEW MINUTES LATER, BY WHICH TIME IT HAD REACHED AN ELEVATION OF PERHAPS 40 DECREES AND WAS ABOUT 20 DECREES TO STARBOARD, I DID NOT NOTICE ANY OUTSTANDING CHARACTERISTICS BEYOND ITS LUMINESCENCE, CROWTH, AND MOVEMENT, AND OF COURSE THE FLASH-ING LIGHT AT ITS CENTER. ON COMING BACK INTO VIEW TWO OR THREE MINUTES LATER, IT HAD BY THAT TIME ASSUMED THE RELATIVE SIZE OF A SIX-INCH BALL AT ARM'S LENGTH, HAD THINNED OUT AND PERMITTED STARS TO BE SEEN THROUGH IT. THE WHITE FLASHING LIGHT WAS AT THIS TIME STILL LOCATED WITHIN THE EXPANDING CLOUD. IT WAS AT THIS TIME THAT AN INTERESTING FACT BECAME APPARENT. MOST OF THE PERIMETER OF THE LOWER RICHT-HAND QUADRANT OF THE CLOUD WAS VISIBLE. VIEWING THROUGH 8X30 GLASSES, I WAS STRUCK BY THE PERFECT ROUNDWESS OF THIS SHARPLY DEFINED LINE, AND THOUGHT IMMEDIATELY HOW THIS MIGHT RESEMBLE A SHOCK WAVE RADIATING FROM A POINT SOURCE. (THIS IS BY NO MEANS A SPECULATION ON THE NATURE OF THE BEAST: I AM SIMPLY GROPING FOR A WAY OF MOST ACCURATELY CONVEYING WHAT I SAW). RESPONSIBLE FOR THIS IMPRESSION WAS THE FACT OF ROUNDNESS, THE FACT OF HIGH CONTRAST ALONG THE LEADING EDGE OF THE EXPANDING CLOUD, AND THE FACT OF VERY RAPIDLY DIMINISHING INTENSITY FROM THE BACK EDGE TOWARD THE EPICENTER.

I BELIEVE AN X-RAY PROJECTION OF A 6-INCH HOLLOW SHERE WITH AN 1/8-INCH SURFACE THICKNESS WOULD REPRODUCE A PICTURE OF WHAT I AM TRYING TO DESCRIBE. THIS WOULD BE QUITE DIFFERENT FROM AN X-RAY OF A SOLID HOMOGENEOUS BALL, WHOSE PROJECTION WOULD SHOW INCREASING DENSITY TOWARD THE CENTER. AND IT IS THIS DIFFERENCE WHICH I WISH TO CONVEY.

I WISH I COULD SAY THAT ALL QUADRANTS NEATLY FITTED THIS DESCRIPTION, BUT THIS IS NOT SO. MOST OF THE UPPER SEMICIRCLE WAS UNOBSCURED AT THIS TIME, AND SEEMED MERELY TO BLEND GRADUALLY INTO THE DARK BACKGROUND. AT ABOUT THIS TIME THE FLASHING LIGHT, WHICH I SAW ONLY AS A FLASH-ING LIGHT AND WITHOUT FORM, ACCELERATED SOUTHWARD FROM ITS CLOUD AND WAS LOST FROM MY VIEW SHORTLY AFTERWARD.

I HAVE AVOIDED DISCUSSING THIS SIGHTING WITH ANYONE UNTIL AFTER WRITING THIS LETTER IN ORDER THAT MY ORIGINAL IMPRESSIONS WOULD NOT BE CHANGED, BEING AWARE THAT IMPRES-SIONS CAN BE ALTERED RETROACTIVELY, UNCONSCIOUSLY, WITHOUT EFFORT OR INTENT.

I THINK ME ROMINGER WILL WANT TO WRITE YOU. IF NOT, I WILL URGE HIM TO DO SO AS THIS LETTER HAS HAD TO DO MAINLY WITH ONLY ONE ASPECT OF THE SIGHTING.

WITH REFERENCE TO MY ENCLOSED SIGNTING REPORT AND ALSO THE 16 DEC 65 8/8 SCHWEDEMAN REPORT (VOL 111, NO 6):

I FEEL SOME WHAT FOOLISH OFFERING THE FOLLOWING TO NICAP IN VIEW OF THE EXPERIENCE AND KNOWLEDGE YOU MUST HAVE IN THIS FIELD, BUT YOUR SCHWEDEMAN ACCOUNT DOES HINT OF YOUR NEGLECT TO CONSIDER SOME OF WHAT FOLLOWS.

IF A BODY ENTERS THE ATMOSPHERE AT A SUFFFICIENTLY SMALLOW ANGLE, AND

IF IT CONTINUES LOSING ALTITUDE, AND

IF THE OBSERVER IS AT A SUFFICIENTLY LOW ALTITUDE, AND

IF THE SIGHTING IS DISCONTINUED PRIOR TO THE ARRIVAL OF THE BODY AT AN OVERHEAD POSITION, AND

IF THE TRAJECTORY, WHEN EXTENDED, FALLS BEHIND THE OBSERVER.

THEN THIS CONTINUALLY FALLING BODY WILL APPEAR TO THE OBSERVER AS A CONTINUALLY RISING BODY.

YOU STATE (REF S/S SCHWEDEMAN) "POSSIBLY THE INITIAL 'CLOUD' EFFECT WAS INCIDENTAL TO THE LAUNCHING, BUT THE EXPANSION INTO A LARGER, GLOWING MASS IS A PUZZLING FACTOR." I OFFER THIS: THAT THE S/S SCHWEDEMAN AND S/S MOUNT VERNON VICTORY CLOUDS WERE NOT THE EXPANDING GLOUDS THEY APPEARED TO BE, BUT RATHER INCREASED IN APPARENT SIZE WITH INCREASING PROXIMITY. AT FIRST SIGHTING THE 6/27 UFO WAS ON THE HORIZON AND, I SPECULATE, MANY MILES HIGH AND MANY WILES BEHIND THE EIGHT-MILE HORIZON, WHILE AT TERMINATION THE CLOUD WAS PERHAPS A VERY FEW MILES AWAY AT MOST. THIS IS A CONSIDER-ABLE RANCE RATIO, AND THE APPARENT EXPANSION WOULD NECEBSARILY FOLLOW THE THE SAME RATIO. RATHER THAN VIEW THE GLOUD AS ME EXPANDING AND "INCIDENTAL TO THE LAUNCHING", THE FOREGOING WOULD PERMIT IT TO BE CONSIDERED IN STRAIGHTFORWARD FASHION AS A SHOCK FRONT, LUMINOUS THROUCH IONIZATION.

BEARING IN MIND THAT THE MID-AIR TERMINATION OF THE 6/27 TRAJECTORY WAS SEEN AT AN ANGLE CONSIDERABLY REMOVED FROM THAT OF THE TRAJECTORY ITSELF, THE SHOCK-WAVE VIEW WOULD THEN ALSO SERVE TO EXPLAIN THE LACK OF SYMMETRY NOTED IN MY REPORT. I SHOULD NOTE HERE THAT THE HIGH CONTRAST LINE SEEN AT THIS TIME WAS NOT SEEN AT ANY POINT WITH RESPECT TO THE UFO (UNTIL AFTER "SEPARATION") THAT SUGGESTED IT COULD NOT HAVE BEEN A SHOCK LINE. MR ROMINGER HAS OFFERED TWO SUGGESTIONS: THAT THE VERTICAL PORTION OF THE DISSYMMETRY MIGHT BE ACCOUNTED FOR BY THE HIGHER MOISTURE OR OTHER CONTENT OF THE LOWEN AIR (AS A CONSIDERABLE VERTICAL SPAN SEEMED LIKELY) AND THAT A CLUE TO THE SPACING BETWEEN THE UFO AND THE SHOCK FRONT MIGHT BE FOUND IN A RECENT RELEASE IN THE SCIENCE JOURNAL (LONDON), MAY '66, P. 9, "MAGNETIC CONTROL FOR RE-ENTRY". NOT TOO MUCH IMAGINATION WOULD SUCCEST THAT J WITH HIGH FIELDS (EVEN ENORM-OUSLY GREATER THAN THE SHO KILOGAUSS MOMENTARY FIELDS DESOR HED ELSEWHERE IN THE SAME ISSUE) MIGHT PROVIDE A MEANS FOR KEEPING A SHOCK MAVE A VERY CONSIDERABLE DISTANCE AHEAD OF THE BODY PRODUCING IT. THIS, IF APPLIED TO THE 6/27 SIGHTING, WOULD PERNIT THE ROUNDED LINE TO BE SEEN AS THE EXPECTED PHENOMENON RATHER THAN, IN THE ABSENCE OF SUCH INFLUENCE, A V WITH ITS APEX IN CONTACT WITH THE GENERATING BODY.

THIS LEAVES THE QUESTION OF THE LINCERING AND DRIFTING LUMINEBCENT CLOUD FOLLOWING "SEPARATION". IN THIS CONNECTION IT NIGHT BE NOTED THAT UPPER-ATMOSPHERE IONIZATION, AS TAKES PLACE DAILY THROUCH SOLAR RADIATION, IS NOT EXTINGUISHED INMEDIATELY AT SUNDOWN BUT TENDS TO LINCER, DIMINISHING CRAD-UALLY OVER A PERIOD OF HOURS.

TAKING INTO ACCOUNT THESE VARIOUS THINGS, A UFO EMERGING FROM A GLOWING, EXPANDING CLOUD SEEMS VERY MUCH LESS THAN ABSURD.





Fage 16 (Thermofex of original constant papers, as is p 16): Dering the first ten minutes of starting, impediately prior to Mr R's baring called me, the SPO wid a much different obsreeteristic than was (News) observed later.

- 1. When first sighted, was shought to be Venue, though exceptionally bright.
- 2. At point "F", p 15, the openff flashing was noted to have begun, and it was no longer thought likely that this might be Venus.
- 3. At this time it was noted that the light had grown very considerably in apparent size, and that the fleshing light was surrounded by a bright helo.
 - . This halo is shown in a negative cause light being dark and dark being light - at the top of page 18. All lines were discriby solatending, only, contrasty, with the lower mendalizate of the halo being st all times much wider that the upper semicircle. While the upperment figure in the intersector would not seem to agree, perhaps through envelopeness in drawing, he did tell me that the figure halo some rather than st at the center of the inner halo some rather than st the center of the inner one.
 - 5. Center of the page (16) shows a disagreement Mr R and I had concerning the direction taken by the flashing light following its "asparation" from the hale. Ref pars 29, p 5. Mr R: Continuation on same course, and with apparent acceleration due to change in viewing angle with UFO approach, with illusion of acceleration increased through the UFO having spent perhaps as long as two minutes behind a dark cloud toward the end of the sighting.

As Mr R has had a 20-year history of earning his livelyhood with a sextant, plus the even more important fact of his enjoying his work. I hesitate to say that he was wrong and I was right (ref again para 29), can only say that at the moment this apparent course change became apparent to me I put down my glasses for a few moments in order to orient myself properly with the foremast and starboard beam.

6. After about ten minutes of sighting, the halo, previously having been very sharp along both inner and outer perimeters, diffused all along its inner edge until, at about the ten minute point, the halo was then for several minutes a seen simply as a glowing ball - with sharp outer edge - having at its center a brilliant, flashing white light.

7. This condition existed, with the ball expanding, until changes were noted as covered in the NICAP report (pages 10 thru 13).

My impression now, after several weeks, is that the flashing light may have been considerably less intense during the last minute or two of sighting than earlier, based on the memory of ### the difficulty of locating it (after it had begun leaving its glowing cloud) and the brilliant stars in the background. (This is answer to your para 13 c.)

Two days ago I received a letter from an organization which heroically pretends to be an independent agency saying, in part, "..., a prominent scientist, checked on some facts for us and discovered that there was a rocket fired from Bikini Atoll within minutes of your sighting. Could you tell us whether you were anywhere near this island at the time or whether this is what you may have seen. I realize that some of your descriptions may not fit in with the rocket launching, but we would still like to know if it is possible that this is what you saw ... " As your own organization may have been the source of this weatherbalooning technique, I quote to you my answer that "At the time of the 27 June sighting, Bikini Atoll was roughly 110 degrees removed from the point at which the UFO first appeared on the horizon." This fact could have been established by means of a two minute expenditure of energy over a chart plot - yet my opinion of the fact was solicited by mail.

With reference to your 8/1/66 letter (page 14), I am pleased that you regard this sighting as being interesting and unique, but question your wisdom in engaging meteorologists to study a phenomena which you know not to be primarily of a meteorological interest.
