I do envy you your Here in New York, we are lucky to see the moon, thanks to the smog and the artificial light, so I've never seen anything like a UFO.

I did receive the copy of your letter to Saturday Evening Post and I wasn't quite sure why the article aroused such displeasure. I didn't think it was very much, one way or the other, and the description on the dover "SECRET DOCUMENTS...!!!" was certainly overblown.

The MINORITY OF ONE (TMO) is at 155 Pennington Ave., Passaic, N.J. 07055. Thanks to the uncompromising independence of the editor, TMO has managed to offend the Left, the Center, and to the Right it is anothera by definition. You may find TMO not quite your cup of tea but it has got the virtue of integrity—no pandering, especially to friends and allies—and of having published an impressive stream of articles on the assassination, from the very beginning. If and when TMO prints my short piece on the two assassinations (JFK and MLK), and/or a long article I submitted on the aborted Texas court of inquiry, I will be glad to send you copies. Why not wait until then to decide whether or not you want to subscribe?

You may pass a copy of my April 4th letter to Mrs. Hartmann, or any parts of it you wish her to see. Why do you say "this will probably be my last letter"??? Are you going to sea? or just disinclined to write any more? I should be sorry not to hear from you again. As for writing another book: I don't know, I don't seem to have the energy. Bobbs-Merrill has asked me to do one on assassinations and I've started some preliminary research, but without real purposefulness or enthusiasm. The labor that went into the Subject Index and Accessories, which I can hardly believe when I look back on it, seems to have done precious little to move us forward towards reopening the case.
