In this cepacity ho hed morked on guns and her fixed gun stotrs to xifles He had ro pecollection of over having secn osithin at loone and Carpencer. Tre. He recalled that folloutng the aseaseination of President Merande he bad mondeced what type of pecpon had been used and he may have orpressed to various individuals not recalled, that he bed xixed a
 MUSRWOOD. SBACY Etated that this Argentine Mansex had no connoction With the assaseination of Eresidsat KENEDDY, homeves, he had comented regatding it following the assassination only because be was conm cerned about what type of peapon bad been used in the assaseinstiom.

STACY recalled that ke had recently gone to a rifle xange in the vicinity of the Sports Drome Speadvay in the 8000 Block, Davie Road, Grand Prairie, Texas in ordez to paratice shooting his xifle. while at the ritide zange he overheard some of the personnel at the ritie zange discussing that LER BABVEY OSWADB had been to the rifle samge at one time ox another.
