Just a note to acknowledge receipt of your recent letters of 18 November and 23 November 1966 and of the suggested topics for discussion that accompanied the latter letter.

I should like to thank you for having kept me posted on recent developments in this case and for having included me in some of your proposed discussions in the immediate future. I am looking forward to our luncheon meeting on Thursday, 8 December 1966 with representatives from LIFE Magazine and also with the proposed meeting with Congressman Kupferman. Both should prove to be very interesting and worthwhile sessions.

As you predicted in your recent letters, things have been "rushing to a boil". It seems that one cannot pick up the newspaper nowadays without reading a comment by some high governmental official or former friend and associate of President Kennedy concerning the Warren Commission Report. I must admit that I am fascinated by all of this, although sometimes I am quite disturbed and angered by the nonsensical and obviously politically-inspired and biased remarks of some of the commentators.

I should like to mention to you at this time that Mrs. Helpern told me in a recent letter that Congressman Kupferman had invited Doctor Helpern to go to Washington with him sometime in January, 1967, presumably to review the autopsy photos. I do not know if this means that he has already received permission from the Kennedy family to examine these films, or whether he is just optimistic about obtaining such permission. In any event, I hope that you and I shall still have the opportunity to accompany Congressman Kupferman, also. I


shall be meeting with Doctor Helpern in New York during my visit next month, and I shall find out exactly what the situation is from his standpoint.

Incidentally, I note that you have not told me exactly where we shall be meeting for lunch on Thursday, 8 December, but I assume that we shall be talking by phone sometime the day before.
