Mrs. ELIZABETH GREGORY, 3513 Dorothy Lane South, advised she and her husband first became acquainted with LEE HARVEY OSWALD in the summer of 1962.

She stated that her husband, PETER GREGORY, teaches Russian language at the Fort Worth Public Library and that OSWALD had contacted her husband to determine if OSWALD was capable of translating the Russian language. According to Mrs. GREGORY, her husband gave OSWALD a test and told him that he was capable of translating the Russian language but there was really no demand for it in Fort Worth, Texas.

Mrs. GREGORY stated subsequent to this meeting they invited OSWALD and his wife to a dinner at GREGORY's home and also invited was GEORGE BOUHE of Dallas, Texas. She stated that this was the only contact that she had in her home with OSWALD.

She stated when they learned that OSWALD's wife spoke the Russian language, their son, PAUL GREGORY, took Russian lessons from MARINA OSWALD during the summer of 1962. She stated PAUL visited in the OSWALD home when he lived near Montgomery Ward Company in Fort Worth, Texas, during the summer of 1962 on several occasions while he was taking lessons in Russian.

Mrs. GREGORY stated that PAUL is presently at the University of Oklahoma at Norman, Oklahoma, residing at 13182 Garfield Street in Norman.

Mrs. GREGORY stated that he has not seen nor talked to OSWALD since PAUL returned to school in September, 1962.

She stated that she had heard of OSWALD through GEORGE BOUHE around Thanksgiving of 1962 and there was some talk of OSWALD having beaten his wife. She stated she could recall no details of what the conversation was regarding OSWALD.

She stated that after OSWALD contacted her husband, she learned that OSWALD had been to Russia and told her husband that he should not have anything to do with OSWALD. She stated after she made this statement, she reconsidered and felt that she may be hypocritical and thereafter/when her son took lessons from MARINA OSWALD.

Mrs. GREGORY stated that she recalled that OSWALD was dissatisfied with work he was doing in 1982, but recalled very little else about any conversations with OSWALD.

Mrs. GREGORY stated that she did not know any of OSWALD's associates and that EOUNE was the only one that she knew of that had any additional contact with OSWALD.
