ROBERT EDWIH <u>EDWARDS</u>; employee, Dallas County Auditors Office, Dallas County Records Building, Dallas, Texas, residence 821 South Eursery, adviced as follows:

He, along with other employees of the Auditors Office, had been permitted to leave work early on November 22, 1963, in order to eat lunch and view the Presidential motorcade scheduled for that date. He ate lunch around 11:30 A.M. and just before twelve o'clock went to the northeast corner of Main and Houston Avenues, there he met a fellow employee, ROMALD FISHER, by pre-arrangement.

Shortly after he arrived there, he and PISHER went to the corner of Eouston and Elm Streets for a better viewing position. At this time, they were facing the Texas Book Depository Building. He arrived at this point about two or three minutes before the motorcade appeared. Just after arriving there, he saw a man on the sixth floor of the above mentioned building who was apparently standing so he could be seen in the corner window.

He described this person as a white man, wearing a light colored sports shirt, open at the neck, and having short, light, sandy hair. He did not recognize this individual and he mentioned to FISHER how unusual it was this man would be in the window and that he wondered what he was doing up there. He did not see a gun at any time, and his attentionwas diverted from this man when the Presidential motorcage appeared.

Shortly after President Kennedy's car passed his position, he heard shots, which he thought were three or four in very rapid sequence, and because of the confusion, he did not again look for the individual he had previously seen in

the window of the sixth floor. He had no idea as to where the shots had come from, and the person he had soon in the window previous to the shooting was visible only from the lower neckline up, and he was apparently standing between boxes which could be seen from the street.

LEE HARVEY OSWALD'S photograph was exhibited to EDWARDS and he could not be sure this was a photograph of the same party he had seen in the window, as above. He did not know LEE HARVEY OSWALD or JACK RUBY by name, description, or photograph.
