Dear Harold:

Someday when I am found dead it will be from reading a right wing editorial in the Wall Street Journal. I know it will give me a heart attack!

In the JFK case, we had the cases of mysterious deaths which turned out not to be anything but a myth. Now we see the same thing in the Clinton attacks. While this particular article is somewhat balanced, Jerry Falwell and the Republicans have been trying to claim that somehow Clinton had a bunch of people bumped off so he could run for President. 2. The Senator's comment ~~that~~ says one should read the Summary of the Warren Report. It also contains a derogatory comment on the media.
