I was in the Honors Program, was fairly close with some of them, but when I went to law school they had some sort of reorganization that resulted in the firing of most of the folks I knew. We used to put on Greek tragedies on stage and other fun stuff.

After the book is on the shelves, I will contact Joe Elliott and see if he wants to have you on his show. He does the 9-12pm shift at night, but also Sunday morning. Most Sunday mornings is open line, but I will explain you cannot stay up past 6pm! He once had Jim Marrs, Jim Moore, and Burt Griffin on his show. I will point out to him that Marrs was on your Selections jacket with a kudo, maybe you can get some good out of that.


On the personal front, Betsy's father Dick is doing well. He seems to be making a good recovery. Betsy stayed up there for about a month.
