→ Send me three copies of Whitewash and three of Whitewash II. I enclose \$50, and I think I have a ten dollar credit. Bill me if extra.


I have thought of sending copies to Judge Burt Griffin. He was on the radio last year, and from his Warren Com. work seems to be a little different than the rest.
