the Russell archive, and he apparently has, because he points out that Sen. Russell thought the assassination was a conspiracy. This tape does not cover any new ground, but it is good for what it is, an introduction to the research community. The problem is, it makes no effort to distinguish between the BS artists, such as David Scheim, and the legitimate researchers, such as you. I'll mail it back to you next week. But Reasonable Doubt is still the best one ever made. Chip Selby is my video hero!

As a point of interest, it turns out that one of Betsy's former employers, who is a national expert on alcoholism and DUI laws, is a longtime friend of David Scheim. When I told him I had studied this for years, he asked what I thought about Contract on America, and was surprised when I told him it was total BS. I am afraid I am getting as blunt as you, but it doesn't do history any good to encourage these Researchers who don't have any facts.

A number of things I feel have never been covered by a documentary.
