Dear Ms. Norris:

I enjoy listening to your show on WHAS. A few weeks ago, you mentioned the assassination of President Kennedy. You seemed to have an open mind on the subject.

A friend and colleague of mine, Harold Weisberg, is the acknowledged expert on the subject of JFK's death and the Warren Report. He has written several books on the subject, some printed commercially and some self-published. It took me about 10 years to get a copy of his first book, Whitewash. At the time, none of his books were available in bookstores, and I wrote him and bought a copy. I was so impressed I donated two sets of his books to the University of Kentucky.

My expertise is in the research I have done at the University of Kentucky on U.S. Senator John Sherman Cooper, the Kentuckian on the Warren Commission. I gave my research to Weisberg, and we became friends.

Weisberg now has available two books from Carroll and Graf, Selections from Whitewash, a compilation of several books, and Case Open, a repudiation of Gerald Posner's books Case Closed. Posner is a fraud, who for example claimed he interviewed James Tague, a bystander who was slightly wounded by one of the bullets which missed the JFK motorcade. However, Mr. Tague informed Weisberg that he never met or spoke to Posner.

Both of Weisberg's books have been published in 1994, and like most authors, he would welcome a chance to be on your show. I believe he especially would like to discuss Case Open.

Weisberg and his wife, Lillian, were awarded honorary doctorates by Hood College in 1993, the only JFK assassination researchers ever to be so honored.

I include some articles about Weisberg and a copy of the

documentary "Reasonable Doubt", the only 100% accurate one ever made. It is the best explanation of the problems with the Warren Report on tape. You may keep it.

I have checked the cites in Weisberg's books dozens of times, and have never found even one error. I have the 26 volumes of exhibits to the Warren Report.

If you would be interested in having Harold Weisberg on your show, contact me and I will give you his phone number and address. Although he is 82, he is sharp as a tack. Over the years, he has appeared on the old Donahue show, as well as a 1993 appearance on NBC's "Unsolved Mysteries", discussing the lack of evidence against James Earl Ray, the alleged killer of Dr. Martin Luther King. He has been on many different radio shows on both coasts.

Weisberg has sued the federal government over a dozen times under the Freedom of Information Act to have information released on both the JFK assassination and the King assassination. Harold is featured in the enclosed documentary, and it will help you get an idea of what to expect if you should decide to have him as a guest.

Weisberg asked me to contact you, and if you have any questions feel free to call me at home or at the office.
