As the interview with David William Ferrie was about to end he stated that he had a very good idea who had reported him as having associated with Oswald, training him in the use of rifles with telescopic lenses, etc.; that he was firmly convinced that one cack S. Martin, who resides at the corner of Esplanade Avenue and N. Frieur Street, had made this false report concerning him. We stated that Martin makes a practice of hanging around the calless of various attorneys, Court rooms, etc., and is well known locally for furnishing false leads to law enforcement officers, attorneys, etc.

Subsequent to our interview with Ferrie on the night of 11-25-63 he was interviewed by FBA Agents at the First District Police Station.

On 11-26-63 it was learned the FBI Agents had talked with Jack S. Martin, who admitted that he had been the informant with regard to David William Forrie; that Martin had admitted to FBI Agents that the information which he had furnished Assistant District Attorney Kohlman was a figment of his imagination and that he had made up the story after reading the newspapers and watching televicion; that he remembered that Kohlman, a former newspaper reporter, had written an article or story about Ferrie a couple of years age and that he pieced the whole thing together in his mind and had given it to Kohlman as facts.

On the night of 11-29-63 SAIC/Rice and reporting agent interviewed John S. Martin at length in his shall run-down apartment located at 13th N. Pricur Street, New Orleans, which he shares with his wife and 6-year old son. Martin, who has every appearance of being an alcoholic, admitted during the interview that he suffers from "telephonitis" when drinking and that it was during one of his drinking sprees that he telephoned Assistant District Attorney Mernan'S. Kohluan and told him this fantastic story about William David Ferrie being Involved with Lee Harvey Oswald. No said he had heard on television that Oswald had at one time been active in the Civil Aik Patrol and had later heard that Ferrie had been his Squadron Commander. Martin Stated that Ferrie's heme and to him; that he recalled having seen rifles in Ferrie's heme and that Ferrie had been a Marine and had been with the Civil Air Patrol. Discreet inquiries were made in Goldonna and Natchitoches, Louisians, on 11/22/63 regarding possible suspect Jack Martin at request of Dallas Office, this investigation having been initiated prior to the arrest of Lee Harvey Oswald.

DETAILS OF DAY STUGATION

At approximately 2:00 PH om 11/22/63, while at the Barkedale Air Force Base in Bossier City, Louisiana, I received telephone call from SA Anthony M. Gorrets in New Orleans. He advised that he had just received telephone call from clerital Lillian L. Rhyan, Dallas, who stated that SA Robert A. Stewart had requested that this cirics conduct discrett inquiries relative to Jack Martin, Route 1, Goldonna, Louisiana, who at that time was considered a possible suspect in the descassination of President Kampady. He further information was then available

I immediately proceeded to Goldonna, Louisiana, arriving at approximately 5:00 I and interviewed Mrs. Irene Modes, Postmaster, Mr. G. C, Quarles, Rural Carrier, and Willie Frazier, Constable and Deputy Sheriff, all of whom are well acquainted with Jack W. Martin, son of Den/and Thelma/Martin, Route 1, Box 4, Goldonna.

The family is peer and Ben Martin is a worker in the logging business in this backwoods community. Jack W. Martin reportedly grow up in the community and did not finished below. For several years the subject has been traveling around the country and apparently has been connected with an unidentified religious cult. It has been rumored, according to Mr. Quarles, that Martin desires to become a preacher.

Constable Frazier said that apparently Martin had never been in any trouble in Goldonia or vicinity, but that he did leave the area about 8 or 10 years ago and was gone for several years. He said he heard that he was either in the armed forces or possibly in prison in another State.

Martin reportedly has never parried, and so far as is known he has never been gainfully employed. He has communicated with his parents by mail from various places throughout the country, and always uses a general delivery address. He reportedly has been in Massachusotts, New Jersey, California, Texas, and other states.

Constable Frazier said he last saw Martin in Coldenna approximately three or four weeks ago. Rural Carrier Quarles said that he believed that Martin's nother had been writing to him in Texas, city unrecalled, recently.

All of the persons interviewed indicated that Martin is quiet and does not have any close friends in the area. So apparently does not hunt or fish, and is not interested in sports. There was no indication that he had a gun or rifle. He is said to be neat in appearance and Sather soft spoken.

Constable Frazier said that a brother, Bobbie Martin, age about 19 years, has been a problem in the community,
