WILLIAM K. STUCKEY, The Ross Agency, Inc., 525 Gravier Street, residence address 2317 State Street, furnished the following information:

He called at the OSWALD apartment alone, 4905 Magazine Street, at about 8:00 a.m. on August 17, 1963, to invite him to appear on his radio program. OSWALD agreed and STUCKEY told OSWALD to meet him at WDSU/Radio Studios, 520 Royal Street, between 4:30 and 5:00 p.m. He stated that his conversation with OSWALD took place on the front porch of OSWALD's apartment and that during the conversation, OSWALD showed him his membership card in the Frir Play for Cuba Committee, which was signed by A. J./HIDELL. He did not know anyone named PETE MOLLAR. Mr. STUCKEY advised that he had never met A. J. HIDELL and from his conversation with OSWALD, came to the conclusion that HIDELL is a fictitious name or an alias used by OSWALD.

STUCKEY stated that an unpublished and unreleased interview with OSWALD was then recorded on tape. The interview lasted for about 37 minutes. He said that officials of the radio station thought that the interview was too long for an interesting program and that he used excerpts from this taped interview on a program known as Latin Listening Post that night. He stated that he then arranged a question and answer program with OSWALD for the evening of August 21, 1963 over Radio Station WDSU. On this program, he invited EDWARD SCANNELL BUTLER, Staff Director for the Information Council of the Americas, CARLOS ERINGUIER, Director of the Student Cuba Directorate for the New Orleans area. This program was broadcasted at 6:05 p.m. on August 21, 1963, in a program entitled, "Conversation Carte Blanche". It was during the latter program that OSWALD stated that the Fair Play for Cuba Committee was not communist controlled and that he, OSWALD, was a Marxist.

NO T-1 stated that it was not possible to search Post Office boxes by reference to mame of the person renting the box; that information concerning the boxes could only be located through reference to the box number.



Mrs. LOUIS N. RICO, 4905 Magazine Street, lower rear apartment (899-4244), furnished the following information:

She stated she has resided at that address since October, 1962. She said that she was familiar with the couple who occupied the rear apartment at 4905 Magazine Street but never knew their name. She said that when she saw the picture of LEE HARVEY OSWALD in the newspaper on November 22, 1963, as being a suspect in the assassination of President KENNEDY she recognized him as being the man who occupied the rear apartment at 4905 Magazine Street from approximately June, 1963 until late September, 1963.

She said that while OSWALD lived at that address he never spoke to anyone and kept pretty much to himself. She said that OSWALD and his wife talked in a foreign language, which she believed to be Russian. She said that she worked during the day so that she did not see OSWALD very often and that when she did it was in the late afternoon when she returned from work. She said she recalls seeing a short, stocky, dark complected individual, who was wearing a dark business suit and looked to be either Mexican or Cuban extraction, enter OSWALD's home approximately three weeks before OSWALD vacated the apartment. She said that she did not believe she could identify this man inasmuch as she only observed the side of his face but was able to closely observe his appearance.

She stated that she also recalls seeing a woman who drove a station wagon bearing Toxas license plates arrive at the Oswald apartment during late September, 1963, and load clothing and other articles into this station wagon. She furnished the following description of this woman:

ALEXANDER 5. EAMES, III, 4903 Magazine Street, (TW 9-4382) furnished the following information:

He stated he has resided at that address for approximately three years and is employed by the United States Engineers. He recalled the couple who occupied the rear apartment at 4905 Magazine Street from June, 1963, until late September, 1963, but did not know their name until he observed a photograph of LEE MARVEY OSWALD in the newspaper on November 22, 1963, who was arrested as a suspect in the assassination of President KENNEDY as being identical to the man who occupied the rear apartment at 4905 Magazine Street. He said that this man was not very sociable and did not speak to him or anyone else in the neighborhood. He said that this man generally sat on his lawn or on his porch reading. He said the man frequently wore his bathing suit. He said that he was under the impression that OSWALD was not employed inasmuch as he was around the apartment most of the time. He said that he often wondered what source of income OSWALD had. He stated that OSWALD apparently liked chicken inasmuch as he observed frozen chicken thawing on OSWALD's kitchen window sill several times EAMES further advised that his kitchen window a week. is directly opposit OSWALD's and that he had an unobstructed view of this window and OSWALD's kitchen. EAMES said that an alley of approximately 15 feet in width separated his kitchen window from OSWALD's kitchen window.

EAMES said that he never observed OSWALD exhibit any guns. He said that he did soe OSWALD in the main branch of the New Orleans Public Library on one occasion and observed OSWALD frequently reading on his porch and lawn.

He said that the only peculiarity he recalls about OSWALD was the fact that he never spoke to anyone and that when he spoke to his wife he spoke to her in a tone of a command and always in a foreign language, which he believed to be Russian. He said that the OSWALDs never had any visitors as far as he knew. EAMES further
