Deginning in 1975 I filed a series of PA requests. These include the FHI and all the other components. I have also filed a number of appeals. To the best of my recollection these appeals remain without response. I re call no re-ords provided by the Original Division. While I have no clear recollection of having provided leads to your Division I am clear in my recollection that I provided Mr. Shes with elaborate details, including of matters certainly within the interest and activity of your Division.

Regardless of what causes this botality of non-compliance. I went you to know that while there is this extensive withholding there also has been the rest widespread.

discontinuous defamatery records that range from outright fabrications to deliberate distortions. Recipients ranged from the press to attorney's General to the President.

When it became apparent that some of this defamatory misinformation was going to be released I asked Jim becar to write both the FBI Director and the Attorney General to make use of the PA possible for me in advance of these disclosumes. Neither responded.

While I have the idea of chaving to sue, it appears that no practical alternative is going to remain. Just yesterday I asked Mr. Lesar when it might be possible for him to file suit for me.

He then gave me a list of Criminal Division files, with brief descriptions.

Of those it appears that wherever else records may be filed, searches should include CO1, CO2 and CD4.

I also make a new request for all records on or about me in FOIA matters, 024. This updates the ignored requests as they pertain to FOIA matters.

I have known some AAGS in charge over the years, three rather well. I do not know that rescords, if any, they left, but I had a working relationship with at least two. With Bries McMchon this pertained to the case of U.S. v Hery Malen et a 1, the Harlan County coal conspiracy case of the late 1930s. I was borrowed from the Senate to be

a working member of the prosecution staff and I did work, from running the teletype machine when there was nobody else to do that to assisting with the preparation of duces tecum subpoences and participating in plea bargaining. With George McMulty, I bollove, this included getting valuable intelligence information into the country, from Chile. I then gave this information to Jimmy Roosevelt and FDR used it in a fireside that dealing/with the Ward member in Latin America. The arrangement was that the Department would make and keep copies. I would like to have copies now, for their historical value.

There was a proposettion in Washington of a Marier County can't operator, Tel Crosch.

I was a Government witness in that case and there must be some records.

That I was so helpful to the Government is, of course, quite opposite the false image created by the PHI and ther components. It provides notive for the present withholdings and it reflects the fact that when information about me was requested, by Congressional countities and the White House, selective and mislanding responses were provided.

There came a time when there was a neutrality act prosecution pertaining to which I might have hed some information. I phoned Calcinal Division, was called back and was asked to go to the them Internal Security Division. While I do not know what records were made I do have some copies of what was provided to the FSI and I have the letter that was written to us, with its enclosure. There has, however, been no compliance with my PA request and those files are now your files. This effort to be of assistance to the Government was corrupted into an alleged conspiracy with a natorious anti-Semite who had given me information I gave to the SEE IND at that time.

When I was researching a book on the Unimerican (Dies) Committee it contrived a case of my interfering with it. It persuaded the Department to try to charge no. A grant jury was used, extensively. The grand jury refused to indict me but it did indict the agent of the Unimericans, one David DuBots Nayme. There is, obviously, a record of U.S. v Nayme, with some of the records those of your Division and some those of the U.S. Attorney.

Aside from transcripts, these records include the false and incriminating statement the PNI tried to get me to sign and I refused to sign, the statement I did sign, and the decision, which includes the plea-bargaining in which the late Congressors Dies was involved. He arranged a suspended scatence for themen who perjured bimself and suggests engaged in other original actitities for Dies and his associates.

I have knowledge of these matters because I had been helpful to the GlA and because the effort to frame me and an associate was so raw. Because of this and the considerable political pressure applied on the then GlA, the prosecution, while vigorous in its efforts to get me indicted, also was outraged. Onesef the prosecution staff saw to it that effer the case was over I would have information with which to protect myself from any similar effort to frame me. The political pressure was helding up the appointment of David Pine to the district court until he tried to get me indicted for Dies. (Edward Curran, also later a federal district judge and chief judge, was then Sine's Sueber Two man.)

I have been informed that O. John Rogge died recently, when he was AAS he informed me that I had been picked up on electronic surveillance of another in whose home I happened to be a guest. I also was responsible for some important intelligence information reaching Rogge in that period. There have to be records.

When one tries to recall events of as much as 45 years ago recollection can't be complete. However, I believe I have given you enough information for believe compliance with a request and appeals offive years ago, a time greater than any claimed backlog of which I have ever heard. I know of other Criminal records, like those participing to the James "arl May case and My getting some of those records and there are embarrassing Criminal records of its refusing to respond to my FOIA requests. I do want them all.
