Jevons WARREN COMMISSION EXHIBITS SUBJECT: On 11/3/66, Mr. Marion Johnson, the Archivist at the National Archives and Records Service who is handling the exhibits and evidence of the Warren Commission, telephonically contacted SA Cortlandt Cunningham of the Laboratory Division. Mr. Johnson stated that Harold Weisberg, author of "Whitewash: The Report on the Warren Report," had requested information regarding the portions of the FBI investigative reports in which the spectrographic examinations were set forth. Mr. Johnson asked if any spectrographic examinations, other than those set forth; in the report of SA Robert P. Gemberling dated 11/30/63, at Dallas, were made and reported elsewhere. Mr. Johnson was told that this matter would be looked into Bufiles reveal that Weisberg was summarily fired from Ξ the State Department but was later allowed to resign without prejudice and not be restored to his job because of suspected Communist or Communistic sympathies. Bufiles also reveal he has had previous contact with Soviet Nationals at the Russian Embassy. Weisberg has also previously written the Bureau concerning the Warren Report and because of his background, no acknowledgement was made.
