## Synopsis:

[REDACTED] raises laying hens and has never experienced helicopters bothering chickens or horses. [REDACTED]

[REDACTED] has lost no chickens due to helicopter flights and she knows of no loss in egg production due to helicopters. [REDACTED]

[REDACTED] states that on at least 2 or 3 occasions helicopters came over the WEISBERG farm scaring WEISBERG's chickens badly. [REDACTED] knows some of WEISBERG's chickens died as a result of these helicopter flights and that egg production was also cut back as a result of these flights. [REDACTED] said helicopters do occasionally fly over this area, however, [REDACTED] has never seen one which [REDACTED] would consider too low.

[REDACTED] said [REDACTED] does not raise chickens or livestock. [REDACTED] has never seen a helicopter lower than the hill in back of the WEISBERG farm.

[REDACTED] definitely had laying hens during the 1957-58 period. K2

[REDACTED] said her husband mentioned a helicopter disturbing his chickens on only one occasion. This was several years ago and he related that one time when he was in the hen house the hens jumped up as though something scared them, at which time he looked out of the hen house and saw a helicopter passing over. He said that this scared the chickens no more than a child walking into the hen house and he lost no chickens as a result. [REDACTED] said that her husband has lost no chickens as a result of helicopters and she knows of no loss of egg production as a result of helicopters flying over the farm. She said disturbances can cause laying hens to stop laying and also cause blood spots in eggs. K2

[REDACTED]

[REDACTED] said he was at the WEISBERG farm on several occasions when helicopters flew over the farm and scared the chickens badly. The chickens would bunch up in the corner of the chicken house, pile on top of each other and cause the death of several chickens. [REDACTED] K2 said he was not at the WEISBERG farm every time a helicopter flew over causing the death of chickens, however, he was there on at least two or three occasions when this happened. He said he knows helicopter flights also cause a loss in egg production of Mr. WEISBERG's hens. He was unable to say how many chickens Mr. WEISBERG lost as a result of the helicopter flights, or his losses in egg production. [REDACTED] said WEISBERG usually kept from 600 to 800 laying hens and from 200 to 300 young chickens.

WEISBERG claims this scares his chickens causing death to several of them and causing a setback in egg production. [REDACTED] advised every time a fire engine went by WEISBERG's farm he would immediately come over to the fire house and tell how many chickens were killed. K2

[REDACTED] said he has seen helicopter flights over this area, however, WEISBERG appears to be the only one in the area the helicopters have ever bothered. K2
