DETAILS OF OFFENSE (Give Circumstances of Occurrence of Offense and its Investigation) Use Both Sides of This Sheet.

Deceased driving Squad Car #10 east on Tenth stopped to interrogate a suspect who was walking west on Tenth. Suspect walked to Officer's car on the right hand side, they talked through the closed window for a few seconds. Deceased got out of the car and started to walk around the front of the car to suspect, as he reached the hood of car suspect started shooting striking deceased once in the right temple, once in right side of chest and once in center of stomach. Suspect ran south on Patton from location toward Jefferson. Suspect was later arrested in the balcony of the Texas Theatre at 231 W. Jefferson. Suspect's gun a 38 Special was recovered and turned over to Homicide Bureau. Deceased taken to Methodist Hospital by Dudley-Hughes ambulance and pronounced DOA at 1:30pm by Dr. Liguori, Judge Joe B. DETAILS

SYNOPSIS

Autopsy report obtained from Dr. Earl F. Rose. Officer Tippit was hit with four shots. However, only three of the shots penetrated. The fourth shot did not penetrate as it evidently struck a button on the officer's coat. The three bullets recovered from the body of Officer Tippit were turned over to the Police Crime Lab. Dr. Rose said that it appeared to him that one of the bullets would be satisfactory for ballistics comparisons.

DETAILS OF INVESTIGATION

Reference is made to previous reports in this case.

On December 9, 1963 I called at the County Medical Officer's office, Parkland Memorial Hospital, Dallas, Texas, and interviewed Earl F. Rose, M.D., County Medical Officer, Dallas County, Texas. A copy of the autopsy report on Officer J. D. Tippit was requested at that time but Dr. Rose stated that he did not have his report ready as yet, but that he would have it completed and I would be able to obtain a copy on December 10, 1963.

Dr. Rose informed me at that time that the officer was hit with four shots but that only three of the bullets penetrated and the fourth bullet apparently hit a button on the officer's coat and this kept it from penetrating the body. When the examination was performed, three bullets were removed from the body and turned over to the Police Crime Lab. (These are now in the possession of the FBI).
