[Gilberto Alvarado, a young Nicaraguan, has alleged that on 9-18-63 he observed Oswald receive \$6,500 in the Cuban Embassy, Mexico City, as part payment to assassinate the President.]

On 11-27-63 Ambassador Mann told our Legal Attache that he had been advised by Alexis Johnson, Department of State, that State and CIA consider Bureau to be in full charge of investigation and expect us to call the shots.

On 11-28-63 our Legal Attache, pursuant to instructions issued by Assistant Director Sullivan, unequivocally advised the Ambassador that the Bureau was not directing the investigation in Mexico and that we considered ourselves to be in full charge of the investigation conducted within the U.S. In discussing this matter with Assistant Director Sullivan, Legal Attache Anderson recommended that the best course of action would be to turn Alvarado over to the Mexicans and request thorough investigation of his charges, including polygraph examination. This course was adopted and the Bureau Liaison representative so recommended to CIA on the afternoon of 11-28-63.

On the morning of 11-29-63 Assistant Director C. A. Evans briefed Under Secretary of State Alexis Johnson concerning the action taken. He said this was exactly what he had in mind and that he realized it was up to him to issue the necessary instructions to the Ambassador. He pointed out that the specific recommendation made by the Bureau as to the handling of this matter was exactly what he had in mind and he felt it fortunate that the Ambassador was getting our professional help.

Oswald's wife, during interview early this morning, definitely places Oswald in New Orleans on 9-18-63 at time Alvarado stated he was in the Cuban Embassy. She maintains that her husband did not leave New Orleans between time of their arrival there in May, 1963, and her departure from there on 9-24 or 25-63.

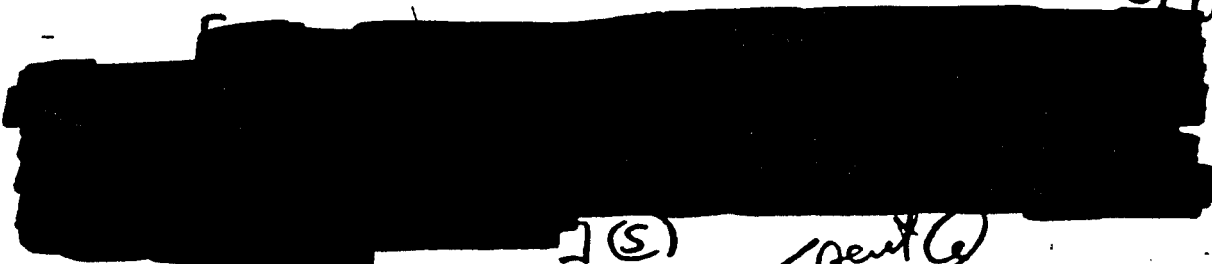
[REDACTED] (We now find per Legal Attache's 11-28-63 cable that Alvarado, prior to his release to Mexicans and on reinterrogation has changed his story, claiming that the 9-18-63 date of the incident may be in error and that it may have occurred on 9-28-63. The fact that Oswald was known to be in Mexico in late September and early October, 1963, has been publicized on 11-23-63 in Mexico City papers in connection with Mexican interrogation of Silvia Duran. This fact is undoubtedly known to Alvarado. As Alvarado, in his first account, said that he again saw two of the witnesses to the incident on a repeated visit to the Cuban Embassy 9-26-63, and as his claimed calls to the American Embassy warning of a killing of a prominent person have not been substantiated and finally as his initially stated reason for being in Mexico in September, 1963] (S)

CONCERNING TRAVEL OF OSWALD:

Our investigation has established that on 9-17-63 Oswald obtained a Mexican tourist card from the Mexican Consulate, New Orleans, and that on the same day he checked in at the unemployment bureau in New Orleans and completed necessary forms to obtain unemployment compensation which is mailed to the recipient by check within a few days. Check of airlines has revealed no passage of Oswald to Mexico under the name Oswald and known aliases on 9-17, 18 or 19-63. Mexican Immigration records establish that Oswald entered Mexico 9-26-63 and he departed 10-3-63. He is known to have checked out of his residence in New Orleans on 9-25-63. New Orleans is pressing inquiry to determine Oswald's whereabouts on 9-18. If he was in New Orleans on that date and it appears likely that such is the case, the allegations of Ugarte placing Oswald in the Cuban Embassy on 9-18-63, will be without foundation.

RECOMMENDATIONS:

1. That Liaison inform State Department and CIA that [REDACTED] the Bureau's investigation in an effort to definitely place Oswald on 9-18-63 is going forward. It is suggested that State and CIA be informed that Oswald has definitely been placed in New Orleans on 9-17-63, that he checked out of his New Orleans residence 9-25-63 and that Mexican Immigration records show he entered Mexico 9-26-63 and departed 10-3-63. *Our position is that aggressive, positive investigation must be continued to completely resolve the Mexico City angle.*

1. That Legal Attache, Mexico City, be advised of the foregoing and of results of our discussion with CIA. Legal Attache is also instructed to follow [REDACTED] steps being taken to locate and identify the unidentified Negro and Canadian referred to by Ugarte.
