NEITHER THIS OFFICE NOR CIA [REDACTED] HAS BEEN ABLE TO IDENTIFY UNKNOWN SUBJECT WHO VISITED CUBAN AND SOVIET EMBASSIES HERE AND WHO AT FIRST WAS THOUGHT TO BE IDENTICAL WITH SUBJECT LEE OSWALD BECAUSE OF TIMING OF VISITS. PHOTOS WERE EXHIBITED AT VARIOUS HOTELS IN CONNECTION WITH INVESTIGATION TO LOCATE PLACE WHERE OSWALD STAYED HERE WITH NO IDENT BEING EFFECTED. THEY WERE EXHIBITED TO EMPLOYEES OF HOTEL DEL COMERCIO WHERE OSWALD STAYED AND NONE COULD IDENTIFY UNKNOWN SUBJECT.

INVESTIGATION CONTINUING TO IDENTIFY UNKNOWN SUBJECT.

IT IS TO BE NOTED THAT CIA STATES THEY HAVE ADDITIONAL PHOTO TAKEN WHEN THIS PERSON VISITED CUBAN EMBASSY OCTOBER 15 LAST, A NUMBER OF DAYS AFTER OSWALD'S DEPARTURE FROM MEXICO CITY. THIS WOULD MAKE IT APPEAR UNLIKELY THAT UNSUB HAD ANY CONNECTION WITH OSWALD.

LUIS ECHEVERRIA, ACTING MINISTER OF GOVERNMENT (INTERIOR) ADVISED WRITER TODAY THAT SILVIA DURAN HAS AGAIN BEEN ARRESTED. HE STATED THIS ACTION TAKEN TO PREVENT ANY POSSIBILITY OF HER FLEEING TO CUBA; HE THINKS SHE CAN BE HELD FOR SIX OR EIGHT DAYS AND WILL BE AVAILABLE FOR FURTHER INTERROGATION DURING THIS

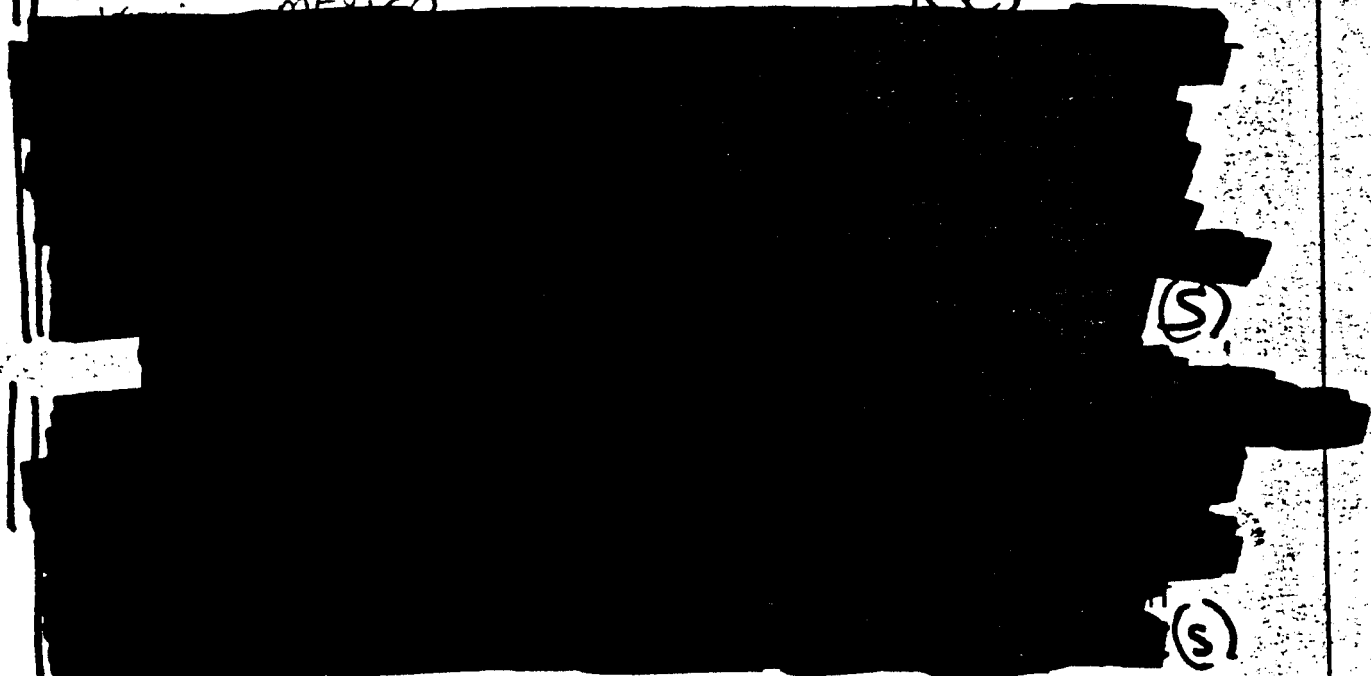

TIME. ACTION IN REARRESTING DURAN TAKEN BY ECHEVERRIA STRICTLY AT HIS OWN VOLITION AND NOT AT REQUEST OF EMBASSY OR THIS OFFICE.

AMBASSADOR HERE HAS EXPRESSED HOPE THAT CLEARANCE WILL BE RECEIVED FROM WASHINGTON TO TURN OVER TO MEXICANS (S) NICARAGUAN INFORMANT MENTIONED IN MY CABLE OF YESTERDAY IN ORDER THAT THIS INFORMANT'S STORY CAN BE USED BY MEXICAN AS BASIS FOR FURTHER INTERROGATION OF DURAN. (u)



IN VIEW OF ALVARADO'S ALLEGATION THAT SUBJECT OSWALD WAS PAID \$6,500 HERE, BUREAU REQUESTED TO ADVISE WHETHER US INVESTIGATION (S)

PAGE THREE FROM LEGAT MEXICO CITY NO. 187

HAS DISCLOSED ANY SIZABLE DEPOSITS MADE BY OSWALD SUBSEQUENT TO HIS RETURN TO US FROM MEXICO ON OCTOBER 3 LAST.

AN EMBASSY OFFICER ADVISED TODAY THAT CONTACT OF HIS TOLD HIM THAT WOMAN RESIDING HERE HAS SON-IN-LAW LIVING IN NEW ORLEANS WHO WAS WELL ACQUAINTED WITH SUBJECT OSWALD. THIS SON-IN-LAW IS CUBAN NAMED ERNESTO RODRIGUEZ WHO LIVES AT 211 JEFFERSON PARRISH, TELEPHONE VERNON 5-9658, NEW ORLEANS. HE RUNS SPANISH LANGUAGE SCHOOL AND IS ANTI CASTRO. APPARENTLY OSWALD MAY HAVE STUDIED SPANISH WITH RODRIGUEZ AND LATTER REPORTEDLY HAS TAPE RECORDINGS OF CONVERSATIONS WITH OSWALD.

UNLESS REASONS EXIST THERE TO CONTRARY, SUGGEST NEW ORLEANS INTERVIEW RODRIGUEZ FOR ANY INFO REGARDING OSWALD'S ACTIVITIES AND TO DETERMINE EXTENT OF OSWALD'S ABILITY, IF ANY, TO SPEAK SPANISH.
