This is a request under the Freedom of Information Act
(5 U.S.C. 552, as amended).

Fensterwald & Associates has been retained by Mr. J. Gary Shaw of Cleburne, Texas, and Mr. Mark Allen, of Washington D.C., to make a request of you for a complete and thorough search of all filing systems and locations for all records (including "see references" or cross references) maintained by your agency pertaining to Silvia Duran, a Mexican woman who worked in the Cuban Embassy in Mexico City in 1963 when the Embassy was visited by "Lee Harvey Oswald." After the assassination of President Kennedy, Ms. Duran was picked up by the Mexican police and questioned extensively. She is quoted at some length in the Warren Report.

In processing this request, please make a search under any aliases or like names of which your agency might be aware.

It is requested that you include with the records themselves any and all indices which are located, as well as all search slips, memoranda, or other records pertaining to the search conducted.

If documents are denied in part or in whole, please specify which exemption(s) is (are) claimed for each passage or whole document denied. Please provide a complete itemized inventory and a detailed factual justification of total or partial denial of documents. Specify the number of pages in each document and the total number of pages pertaining to this request. For "classified" material denied, please include the following information: the classification (confidential, secret, or top secret); identity of the classifier; date or event for automatic declassification, classification review, or downgrading; if applicable, identity of official authorizing extension of automatic declassification or review past six years; and, if applicable, the reason for extended classification past six years.
