REMAIN

COMMITTEE CONCLUDED, in general, that CIA and Intelligence operations not involved. That is highly misleading. They concluded, on the basis of a documentary paperchase, that the agencies as a whole were not involved in the assassination. I agree - of course THE CIA or THE FBI did not kill the President. Yet documentary searches are - as the committee learned - far from conclusive. As the Senate Intelligence Committee learned early on, even the FBI has "No File ~~xxxxxx~~Cases" -- material that is deliberately never filed under such and such a heading. Assassinations Committee enquiries showed that the same was true at the CIA. Then there is the matter of destruction of ~~xxxx~~files that did exist. It was especially concerned ~~ix~~ to discover, without question, Army Intelligence had held a file on Oswald before the assassination, ~~but~~ <sup>that it was from the Warren Commission</sup> that this had been "routinely destroyed". It found this "extremely troublesome" and ~~xxxxxx~~went out of its way to state that thus "the question of Oswald's possible affiliation with military intelligence could not be resolved".

Then there is obstruction.....UPSUM MEXICO CITY.....
