- 1 Resolved, That the Committee on Interstate Commerce

- 5 from officials and employees of the Federal, State, and
- 6 local Governments, and (2) installation of dictographs or
- 7 similar devices for the purpose of listening to or recording
- 8 conversations participated in by such officials and employees.
- 9 The committee shall report to the Senate as soon as prac-
- 10 ticable the results of its investigation, together with its recom-

- 1 mendation for the enactment of any remedial legislation it
- 2 may deem necessary.
- For the purposes of this resolution the committee, or
- 4 any duly authorized subcommittee thereof, is authorized to
- 5 hold such hearings, to sit and act at such times and places
- 6 during the sessions and recesses of the Senate in the Seventy-
- 7 sixth and succeeding Congresses, to employ and to call upon
- 8 the executive departments for clerical and other assistants,
- 9 to require by subpena or otherwise the attendance of such
- 10 witnesses and the production of such correspondence, books,
- 11 papers, and documents, to administer such oaths, to take
- 12 such testimony, and to make such expenditures as it deems
- 13 advisable. The cost of stenographic services to report such
- 14 hearings shall not be in excess of 25 cents per hundred words.
