Dear Mr. Weisberg:

Please advise me on how I may purchase your books from the Whitewash series. A self-addressed stamped envelope is enclosed for your convenience.

Thank you for pasting Posner's mythical "Mind Closed" in "Case Open," which I buzzed through in a few days. I hope you sent him a copy.

Last week, in the Brown University bookstore, I saw Case Open displayed just a shelf or two away from the Posner novel. Unfortunately, however, your two new books are almost impossible to track down in this area. In fact, local booksellers say they know nothing of the forthcoming "Never Again!" (No publication around here reviewed Case Open or Selections From Whitewash.)

At the time of the coup, I was a fifth-grade student playing outside during recess. When we came back into the classroom, our substitute teacher was sobbing, and she told us the news.

That weekend, my parents and I cursed the lamb every time he appeared on TV. We all wanted him to get the death penalty. We cheered when Ruby shot him, and thought Ruby was a national hero who should not be charged. Years later, we began to realize the government had played a cruel joke on us.

I've seen you a few times on TV, including The Men Who Killed Kennedy. ~~I'm currently immersed in Selections From Whitewash -- easily the most fascinating book I've ever read.~~ What a terrible shame it is that a man of your intelligence, coherence, and integrity should be ignored by the media and unknown to millions of Americans affected by those murders.

Two months ago, I got a taste of your frustration in my first brush with Washington bureaucracy.

I had some truly impeaching evidence to present against Judge Stephen G. Breyer during his Senate confirmation hearing - much more damning than anything offered by his opponents who actually testified. However, Joseph Biden and Arlen Specter colluded to silence me in an unconstitutional manner (but I did manage to squeeze an affidavit into the record by working sixteen consecutive hours on it and express-mailing it just before Biden's deadline). So, a deceitful, dishonest, and quite stupid politically-connected hack will join the Supreme Court. Another fraud foisted upon the slumbering public.
