**Re: NOTABLE OBSERVATIONS THAT HAVE TRANSPIRED SINCE EXPOSING
THE EX-FBI AGENT FROM BEVERLY HILLS**

To all:

It has been approximately 4 weeks since this information has been disclosed to numerous reporters/journalists and others in the US and Canada. There are some notable observations that have taken place:

1. The establishments that are mentioned in the Witnesses list have almost all acquired **NEW EMPLOYEES**. These particular employees are very apt to answer any questions immediately upon your entry into the establishments. Please note, these are in fact NEW employees. I have visited these establishments frequently for years and have NEVER seen these persons before.
2. The persons employed in the establishments mentioned in the witnesses list must be on extended holidays or working odd hours. Definitely a deviation from the normal routine.
3. Some of the telephone numbers listed in the Witnesses list have been completely disconnected.
4. My neighbor (#13 Guildcrest Dr.) has completely vacated his home. I have not seen these neighbors in almost 4 weeks. They did in fact vacate 2 days after I disclosed this information to journalists.
5. I have been in 4 automobile accidents¹. I have not been seriously injured in any, but I will state that the intentions of the other drivers are premeditated. Without question.
6. A Break and Entry did occur on 12-16-95 @ 06:15 EST to my home on 11 Guildcrest Dr. The two rear doors to the home were left completely wide open. Nothing was stolen. Police reported the incident.
7. Activity around #9 Guildcrest (the residence where I firmly believe the surveillance team was/is stationed) has been subdued. Notably subdued.
8. My Discover Card account (my only line of credit) has been inactivated.
9. I have been asked to leave and never return to a Yacht Club (Cathedral Bluffs Yacht Club) that I am a member of and have visited for over 4 years.
10. The Office of the Director of the FBI-Louis Freeh refuses to acknowledge a manuscript Federal Expressed on 11-9-95. The secretary refuses to allow me to communicate with Mr. Freeh.
11. The OPR also refuses to acknowledge a FedEx priority package delivered on 11-9-95. However, "Shamell" states that Agent Vellis has had but no complaints.
12. The secretary of Herb Grey (Herb Grey is the acting Director of all RCMP activities) refused to acknowledge a plea I gave to cease the violation of my Canadian Statues (a right that every Canadian citizen holds-"in no way should the legally implemented surveillance be used to harass the subject"). The secretary refused to give his name, and was unable to advise/aid me with the violation of my rights.
13. The US Dept. of Commerce, returned a FedEx Priority Pak (with contents similar to this one) the day after this Dept. had received it. Another point worth indicating with respect to the return FedEx Pak is the absence of a signature from the US Dept. of Commerce.

To all:

It has been 24 hours since the information in OBSERVATIONS#1 has been disseminated to other persons/organizations..
There are some notable observations that have taken place:

1. Approximately 4 hours after the document entitled OBSERVATIONS#1 (please read OBSERVATIONS#1) was taken to a copy center to be duplicated 300 times, the lights in #13 Guildcrest are turned on. Consequently, I had gone over to investigate. The person inside, I had not seen before. However, she did acknowledge that they were gone for weeks, and returned today (12-19-95).

**Re: NOTABLE OBSERVATIONS THAT HAVE TRANSPIRED SINCE EXPOSING
THE EX-FBI AGENT FROM BEVERLY HILLS**

To all:

Approximately 4 months after this information has been disclosed to numerous reporters/journalists and others in the US and Canada, the following observations are noted:

1. The General Manager of "Kelsey's", a restaurant/bar I visited frequently, has been reassigned to a West End City location. He was beginning to witness some strange occurrences at the bar, during my presence there. He held the position at the Ellesmere/Markam Rd. location for more than 3 years. He moved just prior to Christmas (about 4 weeks I had written to several hundred reporters).
2. "Mike", the General Manager of the Business Depot on Eglinton Ave. in Scarborough, has been reassigned to G.M of the McCowan Rd. location.
3. Some of the telephone numbers listed in the Witnesses list have been completely disconnected.
4. My neighbor (#13 Guildcrest Dr.) as of 03-01-96, have moved their furniture and belongings out and the home is completely empty. (the same neighbors that talk and pull dead dogs out of a swimming pool, and go out of their way to ensure that my family is an audience to the strange event).
5. I have been in 20 automobile accidents. The latest involved my Chevette being struck by a large jeep, and completely destroyed. This happened just one day after I had painted my Chevette with the logo-"Regulate the FBI". This phrase was painted on all sides of the blue car with white spray paint.
6. The car suddenly became inoperative while driving on Markam Rd. I had to abandon the car to call a Tow Truck. That's when the driver of the jeep completely demolished the car, only to say afterwards-"I didn't see it".
7. Activity around #9 Guildcrest (the residence where I firmly believe the surveillance team was/is stationed) has been subdued. Notably subdued.
8. Discover Card representatives claim they have lost a certified bank draft that I sent to them via FedEx courier. (FedEx # 400-7734-1434). This information was supplied to me over the telephone by "The Supervisor", Beverly on 02-09-96 @ 16:39 EST. Her exact words were, "Sorry, your \$60.00 advance payment is LOST!"
9. I have been asked to leave and never return to THE PITBULL GYM by the PHILIS (the owner's sister), on 12-06-95 @ 16:50 EST. Her exact words were-"Your disrupting other members... Your talking of the FBI is disruptive to members... We've had many complaints). But, after I had told this to various people (my family members, and people at the Good Life Fitness Center), PITBULL GYM suddenly calls and leaves a message on my Bell Canada answering service -"You are the winner of a year's free membership at the Gym, courtesy of the draw you filled out". I NEVER filled out any draw at PITBULL GYM, or for that matter anywhere else.
10. After telephoning Federal Express for tracking numbers on a several packages that I delivered to the Department of Justice via FedEx almost a year ago, the next day, I receive a letter from the Department of Justice stating that they are sorry for delay.
Also, one other point to note, is that the Department of Justice indicates in the letter that John Vellis is an Ex-FBI agent. I had phoned and even faxed every Fax machine at The Department of Justice (for a copy of the aforementioned letter, see the exhibits immediately following the INDEX DIVIDER-"JUSTICE, DEPT.".)
Just like I had suspected, we are seeing the early signs of the "Development of the False Sponsor²".
11. My friend (I had thought he was my friend), Stephen Shadlock, suddenly is promoted to the elite Toronto ETF (Emergency Task Force). He now makes a habit of periodically visiting and informing my family that I am suffering from "delusions", and that I should take the medication prescribed by Dr. Cruz.
He/also seems to have this big smile, where only months before he was looking as "white as a ghost". I cannot believe my eyes. I cannot believe I once called this individual my friend.
