To all:

I had instructed "DAPHNE" of the printing and duplication center, in the Business Depot Ltd (the same business depot under the former management lead by "MIKE", who, had instructed an employee named DAN GALLANT to deliberately remove parts from a printer box, on more than three occasions) on Saturday, 09, 1996, to replicate the A41 page desument (centering highly constitute foreprise surdame, and other information correlations a man's

the 441 page document (containing highly sensitive forensic evidence, and other information corroborating a man's innocence and an institutions sadistic fraudulent affairs).

Daphne had stated that out of the 15 copies I wanted replicated 3 would be completed and ready to go by 15:00 EST the same day. My father, Dr. Michael Stuparyk and I, arrived at the Business Depot on 1980 Eglinton Avenue East, Scarborough, Ontario, M1L 2M6, at 2:55 EST (the same day).

Daphne was in the final process of completing 1 replicated copy of the original. After completing the first replicated copy, I asked to inspect it, while she was to continue on to complete the other 2 promised copies.

I noticed upon examination of the replicated copy that the following pages were absent:

• Page 208

Page 209

Pages 400-412 (polygraph results from Altech Investigations Inc., etc)

Also, the replicated copies of ALL UPS MAIL AND DEPARTMENT OF JUSTICE DOCUMENTS were extremely poor quality copies. The copier used by this company is a automatic feed type copier, thus the initial setting would dictate the quality of all copies. It was apparent to myself, and my father that the settings must have been changed during the copying of these particular documents.

The missing documents (of critical importance) and the poor quality of other crucial documents lead me to query the staff. In the presence of my father, Dr. Michael Stuparyk, I asked "Daphne" why pages 208, 209, and 400-411, were absent from the bound booklet she just handed me to inspect. The discussion that took place immediately thereafter is noted below: DAPHNE:"I don't know" (a response to the missing pages)

DAPHNE:"Are you sure?"

MATT:"Yes"

DAPHNE: "Wait I'll check the other booklets (which were on top of the large table directly in front of my father, and I) that needed binding"

DAPHNE:"Well, all the other booklets are missing the same pages"

DAPHNE"I am sorry, but the pages must have gotten stuck and missed being copied!"

DAPHNE: "THE MANAGER' MADE THE FIRST COPIED BOOKLET. I'll ask him (Arun, the office manager of Business Depot at the aforementioned local) if he knows what happened."

Daphne then picked up her internal phone and called Arun, the manager, who was just several feet away at the cashier's desk.

Arun, the manager, finally came over. He did not say much, and when he did he did not make any sense at all. This was it. My father finally realized something was wrong and he himself pulled the pen out of his vested wallet and began to ask for names.

On the trip home, after 4 long years of constantly confiding in my father as to the bizarre incomprehensible events that had, and were transpiring, he became aware that maybe what his son had been saying over the years was correct.

My father was shocked, and had not said a word the entire 20 minute auto trip home.

I felt a sense of relief I had not felt in quite some time.
