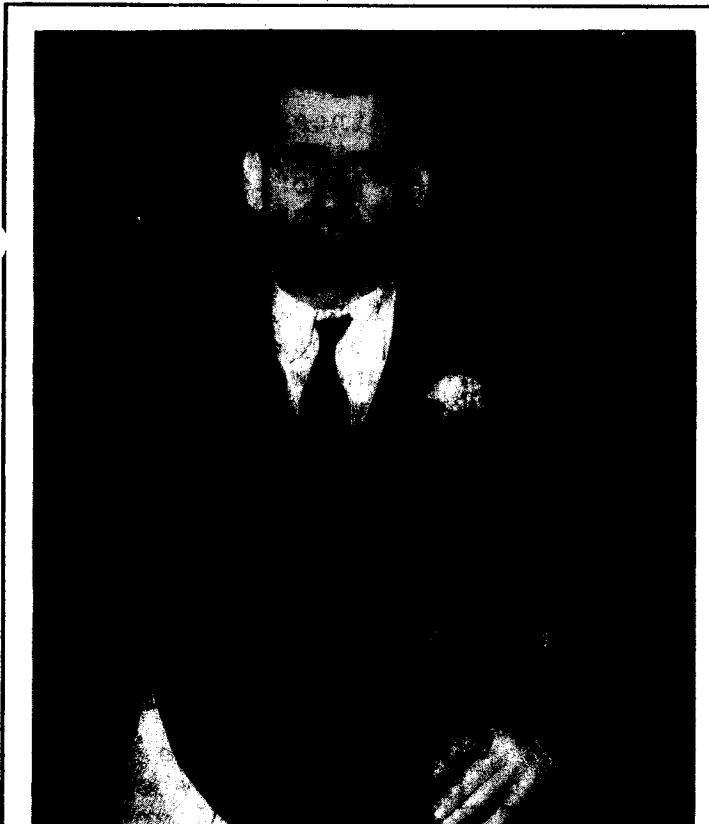

## LOS ANGELES NAZIS TRY BALLOT-BOX BROWBEATING

"I am hopeful that members of the (Los Angeles) Board of Education who are up for election (on April 1st) will not allow themselves to be swayed in their decision by such a group."

This quotation is from a letter (illustration on page 2) by Dr. Russell W. Starr, Chairman, Public Relations Committee, The American Legion, Department of California, addressed to the Los Angeles Board of Education. It throws into bold relief a brazen attempt at ballot-box browbeating made last week by Los Angeles anti-Democrats of the Nazi and affiliated subversivist types. The strategems employed were all the more vicious because of their clever timing; they were scheduled so as to influence city politics on the eve of the forthcoming local elections. With the long arm of Goebbels' propaganda reaching out to intimidate teaching staff and Board of Education, it became evident that it was the Los Angeles school system which had been selected as testing ground for yet another wrinkle of Nazi infiltration.

Swastika propaganda assignments on the Pacific Coast are frequently entrusted to such militant pro-Nazis as Dr. H. A. Gebhardt, legal adviser of the Los Angeles Reich Consulate, and F. K. Ferenz, notorious for his former activities as exhibitor of German propaganda pictures. Both these redoubtable, as an opening gun in their new efforts to totalitarianize this country, joined forces to silence Sam Evans, a teacher who is fearlessly exposing Nazi propaganda tricks in his Current Events classes. Addressing adult audiences, this teacher looms all the more dangerous to Nazi aspirations as he consistently, and convincingly, backs up his statements with documentary proof.

Lectures in which Evans repeatedly referred to rampant Nazism were regularly attended by Ferenz, who continuously heckled the speaker despite the fact that these classes are not of the open forum type. Eventually, Ferenz and his cohorts became so bold that, although Evans himself did not object, the librarian in charge of one of these meetings asked the Nazi platoon to leave. When, undismayed, Ferenz and bodyguard again appeared at the next lecture, Evans took occasion to point out that he had not previously objected

to the presence of Ferenz et al, because their behavior furnished first-hand demonstration of how Hitler's Fifth Column operates. Evans then proceeded to acquaint his audience with Ferenz' background, bolstering his statements with quotations from NEWS LETTER of January 1, 1941 and October 23, 1940. Ultimately, Ferenz left the lecture hall, vowing vengeance.

To make good Ferenz' threat, a meeting of the *Stadt-Verband* (German-American Alliance) was held on Friday, March 14th, at Turner Hall, 936 West Washington Boulevard. Ferenz himself took the floor to offer a resolution to the effect that delegates of the *Stadt-Verband* be instructed to cover all lectures where, as he termed it, "anti-German propaganda" was being disseminated. In addition, Ferenz' resolution demanded Evans' immediate dismissal. Delegate for delegate, representing practically every Americagerman organization in the Los Angeles metropolitan district, enthusiastically supported the resolution. It seemed slated for complete success inasmuch as it would be thrust into the

Board of Education's lap on the very eve of municipal elections. To lend still more weight to their campaign, Ferenz' henchmen also agreed that a blacklist be draup of all persons suspected of "anti-German" sentiments.

But difficulties now arose as to a suitable stooge who could tackle the job of black-jacking the Board of Education into supine submission. Obviously, neither Ferenz nor Gebhardt would do since they have carried the swastika banner so often that their Nazi connections are notorious by now. A new standard bearer had to be found, preferably a man whose political background was unknown and who was a native-born American with a gift of gab.

He WAS found....indeed, quicker than a Bundit could spell B. Tarkington Dowden!

Enter: "The Colonel"

So far, the Nazi campaign to overwhelm the Los Angeles Board of Education had been carried on behind the carefully guarded doors of swastika hangouts. When the

Gentlemen:

It is my understanding that another hearing is scheduled before your Board regarding the status of Mr. Sam Evans, teacher in the Adult Section of the Los Angeles City Schools, and that a considerable disturbance was created by a group who recently appeared before you, demanding a termination of his employment.

We believe that the National Policy as laid down by the President and Congress of the United States should receive every support that we, as individuals, and you, as members of the Board of Education, can possibly give, and that no one should be penalized for following such a course.

## Slate Forum On British Propaganda

"British propaganda and how it is leading us into the war" will be discussed by Col. B. Tarkington Dowden at the Hughes Forum in the Embassy Auditorium at 8 p. m. tomorrow.

The formal subject of the colonel's address will be, "After the Lend Lease Bill—What?"

But the colonel said he would spend a good part of his speech handling the subject of British propaganda—"and," said the colonel, "without gloves, spats or monocle."

He declared he would probe not only into devious methods of British propaganda and how it is designed to sacrifice millions of American lives for somebody else's war, but he would go into the actual effect of the war on Los Angeles.

anti-Evans Blitz actually got under way on March 15th, it started out inconspicuously enough in the form of a run-of-the-mill item, appearing in The Los Angeles Evening Herald & Express (illustration on this page) to the effect that T. W. ("Save America First") Hughes' forum had slated one "Col." B. Tarkington Dowden (illustration on page 1) to speak on British Propaganda and how it was leading us into war.

This notice, as legitimate a piece of public information as can be imagined, was a dead give-away as far as the announced speaker was concerned since it definitely identified him with Hughes' Bund-affiliated group of militant anti-Democrats! Otherwise, with utmost circumspection, the slightest hint had been avoided to arouse suspicion that Dowden might be a new foil for the Gebhardt-Ferenz stormtroopers. To all appearances, he was just another good American availing himself of his constitutional right to blow off political steam in any direction he saw fit. But then, NEWS LETTER dipped into its files, and here is what The Colonel's dossier revealed:

Dowden -- if one swallows what he himself dishes out -- is a bit of an adventurer and definitely a man of strong anti-British and commensurate pro-Irish leanings. In fact, he likes to hear himself introduced as descendant of the "O'Dowden clan" and "a member of the Irish Free State"...whatever that may be, considering that The Colonel loudly proclaims himself as a 100-percent American. After being discharged from the AEF as sergeant-major, he drifted into the Mexican army where, as he claimed, he was eventually adorned with the title of "Colonel". He pretends to be very well versed in

matters Mexican, and incessantly preaches that the anti-Gringos feeling is still very strong south of the Rio Grande, even children being taught to hate every "damyankee".

Contrary to various boasts that he is worth more than a half million dollars, investigation revealed that he is merely running a two-by-four express agency at 1218 Long Beach Boulevard, under the firm name of "Package Fast Freight Company". At this Los Angeles address, he occupies a cubby-hole of office, sharing space with the Standard Motor Express. He operates a package pick-up business, drawing his clientele from department stores, garment manufacturers, etc., all over the Southern California territory. He does not operate any trucks under his own name, but all pick-ups are made by the Standard Motor Express. There are indications that Dowden's business affords him a modest livelihood which, at one time, in a surprising burst of candor, he himself estimated to be from \$50 to \$100 per week. His personal property consists only of such items as personal effects and a car. Apparently he has no banking connections in his own name, payments usually being made in cash and by checks collected from clients, and sometimes by means of a small account maintained in his wife's name.

Dowden -- still following his own story -- first began to dabble in international politics when he assisted Eamon de Valera in floating the Irish Liberty Loan in the United States. In his speeches, he likes to harp back to this period, and never misses a chance to expatiate on British atrocities in connection with Black-and-Tan uprisings. Usually, he climaxes such speeches with the assertion that "Great Britain committed more atrocities than Germany

ever did". He voiced this opinion at a meeting of the America First Committee on February 27th. In that speech, he treated his audience to a very striking self-analysis when he confessed:

*....I'm an opportunist and I'm not ashamed to admit it. Personally, I could live under any government and get along famously. If it appears to be to my best advantage to agree with any old kind of a government, I would just go ahead and agree wholeheartedly. I never miss an opportunity that comes my way!*

Throughout his entire speech, unabashedly anti-Democratic and savagely antagonistic to the Washington administration, Dowden related observations which he claimed to have made in post-Armistice Germany. In this connection, he frequently borrowed phrases and especially opinions from Julius Streicher's *Stürmer* whose lingo he speaks with remarkable fluency.

According to the publicity notice for which Hughes had managed to grab space in *The Herald & Express*, The Colonel was all set to indulge in similar assertions on March 16th, when scheduled to address the Save America First meeting.

This particular oration by The Colonel never took place because no less a light than Verne Marshall put in a personal appearance at the Hughes meeting. The Colonel did not get the floor for more than a few minutes, during which he merely announced that his scheduled address on British atrocities would be postponed until the coming Sunday. However, he took abundant time to state very emphatically that "tomorrow" (Monday, March 17th) he would personally attend the meeting of the Board of Education, to demand the immediate dismissal of "Sam Evans, that British propagandist". Dowden exhorted all anti-Democrats present to be sure and attend that public meeting -- an admonition which brought some fifty henchmen of Gebhardt and Ferenz -- always to be found at Hughes' meetings -- to the Board session.

#### The Blitz is Blitzing

It was at that meeting of the Los Angeles Board of Education that The Colonel was granted the floor. He made strenuous efforts to impress the member of the Board with his importance as a substantial taxpayer who, being "worth \$600,000, contributes a sizeable sum to the public exchequer". Eventually, he began to read from a lengthy manuscript -- copies of which he was prepared to hand out to newspaper reporters, as he announced! He was then advised to submit his memorandum to the Board. Endeavoring to assume the part of a devil's advocate by using his opponent's arguments to strengthen his own case, The Colonel denounced in his memorandum such utterances of Evans as the following:

*The United States has already been invaded by Hitler. I mean by this that Hitler's favorite invasion of propaganda has started here with a vengeance. Hitler always starts his conquests in any country by trying to convince that country to isolate itself from the other democracies. When he has persuaded the country that what happens to other countries is none of its business, then he has a flying start on his policy of divide and conquer. Even though the Lend-Lease Bill has been passed and is the law of the land, there is still opposition to it. If the advocates of disunity in this country are not on Hitler's payroll, they ought to send him a bill. He will be glad to pay them.*

During the entire meeting, proceedings of the Board were continuously interrupted by voices shouting, "We are good Americans!", and "We are taxpayers!" There is ample proof that these vociferous "good Americans" were re-

cognized Nazis. When a photographer tried to take their pictures, they threatened to smash his camera, well aware that a photograph would be a sure means of identification. Dowden, however, rather smugly posed for his picture.

From talk among The Colonel's cohorts, it could easily be gathered that they figured that pre-election time was just the moment to win an anti-Democratic victory by means of intimidating the Board of Education. Indeed, The Colonel repeatedly admonished his pro-Nazi henchmen to be on hand again at the Board's next meeting (on Thursday, March 20th) when he would continue his efforts to have Evans fired. In view of the circumspection with which this psychological moment had been picked, the Dowden crowd were confident of an early and complete victory; eagerly they looked forward to Thursday, when The Colonel would mop up the entire Board.

A Vanishing "Good American and Taxpayer"

However, when the Thursday session was called to order, The Colonel failed to show up. But there was Herr Ferenz with his retinue of Bundits and representatives of such Nazi-affiliated groups as Hughes' Save-America-Firstlings, the American Honest Money Legionnaires, and the National Legion of the Mothers of America, whose headquarters in Hollywood is just around the corner from that of G. Allison Phelps, well-known hater-baiter.

Presently, the Board meeting got under way but, lacking their bellwether, the Dowden flock failed to "blitz" and, in the end, drifted meekly out of the hall. The Colonel was found sitting outside, with the ready alibi that he had been held up in traffic and thus missed his great chance.

What had really prevented The Colonel from putting on his act before the Board was that, wide awake to the situation, The Hollywood Citizen-News had printed a front page item (illustration on this page) to the effect that

*the German American Bund was attempting to force the discharge of Sam Evans....on the ground that he was spreading pro-British propaganda.*

The Citizen-News also referred to a statement by a high American Legion representative, who said that he understood Nazi sympathizers planned another demonstration....before the Board of Education.

This statement referred to the letter of Dr. Starr which was reprinted practically in full.

In view of such opposition, The Colonel found it most convenient to be detained in traffic, but he was by no means ready to throw in the sponge.

# Bund Charges Flare Up In School Row

## Legion Says German Sympathizers Back Of Evans Ouster Move

A charge that the German American Bund was attempting to force the discharge of Sam Evans, adult evening high school instructor, on the ground that he was spreading pro-British propaganda was hurled today by a high American Legion representative, who said that he understood Nazi sympathizers planned another demonstration this afternoon before the Board of Education.

Dr. Russell Starr, state Legion chairman of public relations and member of the Americanism Committee of the Legion County Council in Los Angeles, dispatched a letter to the school board declaring his belief that he could "produce proof that a considerable number of the Bundists should be penalized for following such a course."

At the same time the News Research Service, Inc., of Los Angeles in a lengthy report charged that protests against Evans were "inspired" by a leading member of the German-American Alliance and a former exhibitor of Nazi propaganda films.

"Col." Dowden Goes to Pasadena

After his ignominious retreat of Thursday, Friday night saw The Colonel making a guest appearance at Pasadena to pep up the meeting of the local America First Committee group, held at the McKinley School. Dowden, in his finest fettle, practically out-did himself spreading germs of disunion. Among his bold assertions were the following:

*....The next bill to come up in Congress will be an anti-strike bill, and right after that there will be the Josh Lee Bill. You are going to pay seven billion dollars! How will you do that? One way will be to force you to be satisfied with the cash-surrender value of your policies....and there goes your nest egg. If you don't like to submit to this, why, the Lee Bill will force you to....You haven't got a chance against the Washington Administration. Better take all your money and spend it until you are bankrupt yourself. Then, when the Roosevelts come for your money, you just say: "We ain't got it, mister!"....By all means, let's copy the Administration. Let's be spendthrifts ourselves! But don't you go and pay cash for anything you buy. Just promise to pay for it in the future, and if you create a shortage of goods, why, there won't be anything left to ship to England (laughter)....Roosevelt is going to use Mexican jumping beans for money and if he does, just come and see me. I'll sell 'em to you wholesale.*

The Colonel went over like the proverbial house on fire when he described how the British had destroyed democracy in Africa and looted the resources of India. Reminiscing on Oscar Wilde and his American lecture tour around the turn of the century, The Colonel maintained that all English lecturers were perverts, which seemed only natural since they came from a people capable of committing the most atrocious cruelties in Ireland.

Dowden suggested that a whispering smear campaign be started against pro-British lecturers and, by way of illustration, then gave his version of his run-in with the Los Angeles Board of Education.

During the meeting, one John Manning expressed himself very forcefully against the California Senate Bill No. 180 and the Assembly Bill No. 273, stating that these bills would put behind bars anybody who so much as dared to criticize

the country's preparations for defense. He asserted that U.S. Attorney General Robert H. Jackson had sent this bill to Earl Warren, Attorney General for the State of California, who in turn "passed it on to some dumb State senators". Manning made the motion that the Pasadena America First Committee group sent a telegram to Governor Olson, calling his attention to these "facts". Manning also suggested that a campaign be organized against members of Congress who voted for the Lend-Lease Law. They should be told "that we no longer consider them our representatives in Washington". To start the ball rolling, arrangements were made to provide all those present with postal cards to unloose "an avalanche of protest". In general, the audience heartily applauded every time the names Lindbergh and Wheeler were mentioned -- which was very often! -- and by and large reacted to every cue that indicated anti-Administrative tendencies.

Since money cannot be collected on any Pasadena school premise, it was suggested that the audience make contributions outside the building so as to assist in defraying printing and wire expenses.

It is most interesting to note that a similar attack against this California Legislature Bill is being waged by the American Peace Mobilization (illustration on page 8). The claim is made that the proposed bill "would completely fascize the state". Similar to the Dowden crowd, the avowed Communists of the American Peace Mobilization are asking fellow-travelers to overwhelm legislators with letters and telegrams. What really lends impetus to their campaign is clearly indicated by their own statement:

*....Assembly Bill #271 would, in effect, outlaw such organizations as the American Peace Mobilization, and make it a crime to conduct campaigns such as we have waged against the Conscription and Lend-Lease Bills.*

When, on February 24th, the American Peace Mobilization held a mass meeting at the Los Angeles Shrine Auditorium to fight the Lend-Lease Bill, the rally was attended by many known Nazi hangers-on.

### "Buy" America Short!

Last Sunday, The Colonel was again at it, preaching disaffection to Hughes' Save America First group at their usual Sunday night meeting at Embassy Hall. In many respects, Dowden's appearance was in the nature of a repeat performance, obviously because he had found that in these groups vicious anti-Administration talk gets a big hand. He again opposed defense expenditures and exhorted his audience not to listen to the advice of President and Mrs. Roosevelt to make sacrifices by foregoing the purchase of such commodities as may curtail the output of war essentials. Dowden recommended that everybody buy as much as possible of just these goods, so as to create a shortage. He also advised that such purchases be made on long-term installment plan arrangements, with payments dragged out so as to be wiped out when "the inevitable national bankruptcy" occurs. The Colonel was most emphatic in his assertion that his suggestion of first creating shortages and then cashing in on national default would be the easiest way to bring the country around to what he considers should be its ultimate destination.

#### **As a Candidate for Re-election to the Board of Education Dr. Askey stands for—**

1. A willingness to devote time and energy to the problems of the local school system.
2. An attempt to understand the educational needs, resources and aspirations of the people of our community.
3. He will continue to fight against communistic indoctrination in our schools. He shall join with those who are determined to "wage relentless war on Communists, Nazi-ists, Fascists until they have been driven from our shores."
4. He is in favor of teaching our children the three "R's" but he looks beyond that to the necessity of teaching boys and girls how to earn a living.

There is a great need of a Polytechnic-Agricultural school in our Southland and such a school can eventually be operated in our school district. He will work for it.

After the meeting had adjourned, conversation in small groups proved that, during last week, Dowden had not talked himself hoarse in vain when he recommended whispering smear campaigns. Word was passed around that, in the forthcoming Board of Education elections, among others, President E. Vincent Askey must be defeated since, according to Point 3 of his campaign cards (illustration on page 7) he promises

*to fight against communistic indoctrination in our schools. He shall join with those who are determined to "wage relentless war on Communists, Nazi-ists, Fascists until they have been driven from our shores".*

These exertions on the part of heelers and heilers to defeat Dr. Askey once more prove the persistence with which Los Angeles Nazis try to interfere with local elections.
