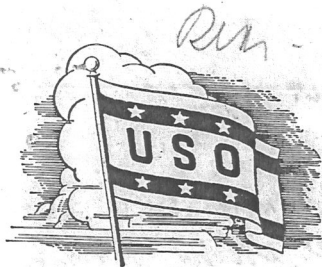


Dear Jim a bit late 5/31/43

I am anxious to get your letter about your new troubles. I hope it turns out alright.

And tell me about Bill. He's quite lucky. But when I think of him - and of me - well. Why did they do it - does he know?

And now I have to go.

Of course, this month's treatment is very much on my mind, but I don't know what to say. I still doubt that I'll be here, about where I will be I can only hope. My feeling is that you should continue with the

a while now.

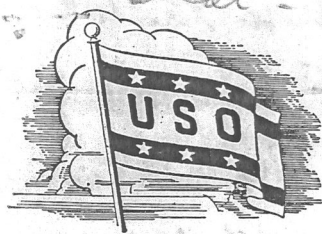
I went to the P.O. & got your letter

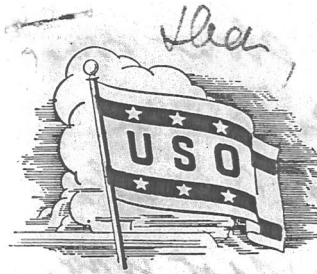
Saw the man Lt. to whom the Col

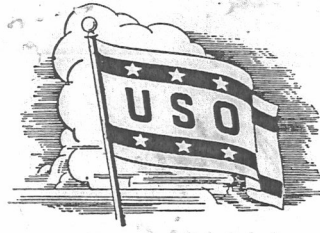
