**FREEDOM OF INFORMATION REQUEST - HAROLD WEISBERG**

Reference is made to your memorandum dated March 13, 1971, forwarding a letter from Mr. Weisberg for comment (Form DS 113, and Mr. Weisberg's letter dated March 4, 1971, and personal check in the amount of \$3.63 attached).

Your attention is directed to your memoranda dated May 19, 1970, and June 22, 1970, and my replies dated May 29, 1970, and July 1, 1970, respectively, concerning previous requests from Mr. Weisberg for photographs and other information from the investigative files of this Bureau relating to the assassination of President Kennedy.

Your attention is also directed to current litigation in the matter of Harold Weisberg v. Department of Justice, USDC D. C., Civil Action No. 80-4-70, in which Mr. Weisberg has petitioned the court, under the Administrative Procedures Act, for other material relating to the assassination.

Since the photographs requested are part of the investigative files of this Bureau and in view of the pending litigation, it is recommended that Mr. Weisberg's request be denied. The attachments to your memorandum are being returned as enclosures to this memorandum.
