(the invisible government) engineered the killing. Could you express yourself on this matter? Especially emphasize who the interest groups were that financed and/or

initiated the killings.

Please note: In 1704 Speaker of the House of Commons, Mr. Robert Harley assigned Mr. Daniel Defoe to be chief spy (author of Robinson Crusoe works). Mr. Defoe applied on a grand scale spying on the English population. This is how Great Britain acquired her empire.

During slavery the slave-master employed informers to oppress men. During "The Great Flint Sit-Down Strike against General Motors in 1936-37," General Motors (DuPont) hired Pinkerton Detectives to spy on the strikers.
