It should be noted that the "acknowledgments" set forth on one of the enclosed pages, gratefully acknowledges the invaluable help, inspirational support, and friendship received from, among others, "several Agents of the Federal Bureau of Investigation."

Because of the ridiculous theory elaborated on in this book, it has not been completely and thoroughly read and the Bureau was not previously advised of the receipt of same by SA GEMBERLING. It is felt, however, the Bureau should be aware of its existence and of its possible publication, and for this reason, the foregoing information is being furnished the Bureau.
