You may also get some interesting advance book news from a comparison of Manchester's interviews in the NY Times of May 9, 1965 and in the London Standard of June 29, 1966. If he is sick, no wonder. He's mixed the unofficial whitewash and the Original is making him sick! His reputation and that of many others now hang in the balance, but not for long. They're done. That NYTimes of May 9 is beautiful. Oswald is a minor figure. The Commission discharged its possibilities on the identification of the assassin and conspiracy "superbly"; and he winds up with a book that says the same thing only the Commission did it badly - he does it well for them.
