CD 87 does tell other whole stories, as I see it. It tell us that the Quigley knowledge if not copy had to include this, and what you do not keep in mind is official awareness of that address, which was FBI-visited as regularly as dogs make their rounds. And Banister and who he had been, and others. It is not only NOPD knowledge at all. Even if we assume, as it is not unreasonable to, that the only lit with this address was that pamphlet.

Note that the FRI, which had long since conducted its investigation, had not communicated with the SSm on this by 12/4. Note also that the reference to 544 is segregated in a separate paragraph and that in the original someone had but a mark at this point in the left-hand margin...That PO is accross the street from 544...

On page 3, middle, paragraph on visit to Dyer:he had much more than one would expect unassisted. The the Marine record, FBI number (coming from what-an arrest andxis \$10 fine? There is at least a suggestion the NOPD had FBI data.

Page 4, middle, before assassination, NOPD had knowledge Cawald had been in Cap. Next per, two names obviously from uniriginak source and third name close to Ferrie, Piezza. Why died during JG investigation, air crash, in which the FAA inspecter who went after Ferrie also died. Now note that on the afternoon of 112/23. Now please note the ellipsis with which Ferrie is introduced in en investigation of Oswald. Dyer may well have known Ferris. The language is so indirect, I acknowledge it is subject to varying interpretations, but I take what follows to mean in consection with the August investigation: Ferrie, "whose name ceme up during the course of this investigation at New Orleans and on whom a seaprate report mx will be filed .... " They could not have enticipated they'd find him in jail, so unless we take this as a declaration of intent, we have to assume there was a Ferrie investigation underway when no one knew where he was and me was known not to be in N.O. Now why would they promise "a spearate report" in advance? They could have said they'd include what they got in a partinent later re orts, or that they'd communicate the results of an interview, etc. But they say there will be a spearate report on Ferrie slone when from the record, they have no reason to believe more than that Oswald and Febrie were or may have been in the CA at the same time. Dyer knew a lot about Ferrie's plane for so early a date end no official interest in him yet. (And it didn't look like it, but it did fly.) Bottom: by "every effort is being made to determine whether the FPCC" ever is d space in 544, what they erevreally saying is they had no reason to believe it dad. This they could have learned by phone and immediately. Well did. Then hid it.

Mext page: no address given as on "The Truth hout Cuba" and absence of any not indicated. This is the exception. Also, by this tile they had three different addresses, all in the block is which I be seve they then were, for the same two-bit outfit- and we also have to believe that hibs, who stored their cars, didn't tell them all about Oswald: I believe their offices were then in the Lafayette P.O., and Alba is bening it, and 544 is accross a narrow St. to the left. It required no time for "every effort to be made".

You twice refer to JG investigations of this. They did zero, to the best of my knowledge, and didn't even interview Newman, whose office is in their bhilding. had him talking until theriff Reid came in and called him outwand shushed him. You have my mamo. You are not wrong to jush NOPD angle, for you know what they had feds also had. If we learn what they had we learn what feds suppressed, which can tell us not only what it is but what it means.

where raul refers to this again 11/3, p. 1, I di not have the recent admissions or correspondence. We smits? Last I had was their refusal as inv. file.

So, aside from the timing of all of this, by the efternoon of 11.25, I think there is other significance indicated above.

On the withheld Ferrie doc, I sent you and Cary copies when I found it in N.O. It is really in the form or a memo by om on naving seen it by accident. It says that "ommon, seistent DA, was interviewed, that Jack Martin had mentione d ferrie to hip, after which he recalled his own knowledge, etc. I have misleid my copy or misfiled it. Sorry I cannot offer you more help in finding it. I think the CD identification was indicated.

I have no record of having Rowley 1/6 ltm. I think part of my wonder is what this list of SSs should be in the front of SD 87 when they are not? It also is loose, added later, not in the binding and without the holes for the binding.

Tage 2, par 3: whether or not you are willing to assume such basic checking was not done, lease believe me, it wasn't. This is the sort of thing 4 had been trying to communicate for so long once 1 detected it. I can add nothing to 196s tenants, but from what \* learned there, born out by examination of building, it is likely that all mail was put at the bottom of the steps inside the 554 door. Jack Martin says when there was suban mail (as Curzeda), whoever first saw it grabbed it (1962) because there was the prospect it had money!
