Dear Gary,

Thanks ^{for} the enclosures with your 8/17. ^{Wonder} ~~if~~ Cyril got an answer. Carl Stern is now the chief information officer for the DJ. Then he was with NBC/TV News I tried without success on a number of occasions to interest him in the JFK and King cases but there came a time when he asked me to go see the ^{DIC} lawyer who knew nothing about FOIA and brief him. I did and after the Act was amended in 1974 Carl filed for the ^Uointelpro records and that was the opening of ~~the~~ that dam to the degree it has been opened.

I did finally find and mail you what I'd promised because I'd just recently seen it in my office. I also sent you an explanation. After your note came today I tried to think of what I can add when I have no access to the records in the basement. I remembered a couple of records relating to that misrepresented ^{State} firing. Rather I remembered what I have two of ^{my} papers relating to it upstairs. I enclose them. One is the evaluation of me by the lawyers I got to represent four of us, all Jews and all Latin Americanists. The other is a page with two stories. The man who quit had to quit, it was that rank. But the odd thing is that he was much less responsible than those who did the dirty work.

That story reflects what I think I told you, that when Bert Andrews put his series of stories together as a book he got that year's Pulitzer. It was that raw, that anti-American, that much of a national disgrace.

So you can see how careful the FBI was to distort the reality. It makes no mention of the public apology or of the Pulitzer ^{for} truthful ^{accurate} ~~reporting~~ ^{reporting} of that native nazism that had taken over in part ~~of~~ of the government.

I do not know what your interest is or what if any use you intend but feel free to do or say whatever you want so far as I am concerned. I'm sorry I can't now take more time for more explanations although if you want more I'll try later. I've lost four days, two for the most pleasant of reasons, and two with a worry that remains. Two dear friends who delivered a fine paper last ^{week} in DC to a socialologist's meeting on institutional failures in the JFK assassination were here and then my wife had what seems to be a painful diverticulitis attack and I've been her nurse more or less, with not the sleep I should have gotten and with the time for two visits to the doctor and to pharmacies and seeing to it that she takes the medication, etc. I've two days of mail to catch up on and orders to fill. Plus keeping an eye on her. She is weak and she is 83. There is more of this demonizing. The CIA's was more careful and less known and there is more + have from the FBI in particular that + cannot get to now. But if you want more, ask,
