

JFK ASSASSINATION: Startling new

Oswald is alive

TWO EXPERTS on the assassination of John F. Kennedy say Lee Harvey Oswald was not the killer and that Oswald even now could be working as a tractor operator on a Russian commune.

"The man who killed President Kennedy was a Russian KGB (secret service) agent impersonating Oswald," says British lawyer and author Michael Eddowes.

"Oswald never left Russia (after his defection from the U.S. in 1959) and he may, in fact, still be alive in that country," Eddowes told GLOBE.

And, according to the other authority, Hugh Ainslie, the Central Intelligence Agency knows exactly where Oswald is.

Ainslie, 58, claims he was a CIA agent until a year ago while working as a foreign correspondent for Reuters news service and American newspapers, including the Houston Post.

He spent 15 years in Europe, five of them in Soviet bloc countries.

Ainslie told GLOBE: "The CIA has known, almost from the very beginning, that Oswald did not leave the Soviet Union, and that he was alive and working on a collective farm as recently as 1978.

"They knew the man who left Russia with a wife, Marina, and a daughter (June Lee), was not Oswald but a lookalike, a member of the KGB's sabotage and assassination Department 13."

record. Oswald defected to the Soviet Union to seek citizenship and returned to the U.S. three years later, in 1962. But Eddowes says: "Oswald was sent to a training camp in the Soviet Union where a Russian lookalike could study his speech patterns and mannerisms.

"Oswald's family im-

mediately noticed a difference between the man who left America and the man who returned."

Ainslie says the CIA did not know why the KGB agent was entering the U.S. posing as Oswald. "When it turned out to be Kennedy's murder, it was too late.

a girl — and was apparently content to drive a farm tractor near Minsk."

Eddowes, with the backing of Marina Oswald, recently attempted to get exhumation of the corpse under the Oswald tombstone in Fort Worth Cemetery.

But he and Dallas attorney Gerry Pittman were blocked by a temporary injunction granted to Oswald's brother, Robert. "We will decide shortly whether to appeal that ruling," the 76-year-old Eddowes told GLOBE from his London home.

Among discrepancies Eddowes claims in the autopsy report on ex-Marine Oswald after he was shot by Dallas nightclub owner Jack Ruby, three stand out:

- Oswald's Marine record gives his height as 5 feet, 11 inches; the autopsy was performed on a 5-foot-9 man.

- Oswald had a scar from childhood surgery behind his left ear. No such scar is mentioned in the coroner's report.

- The Marines' medical report mentions a three-quarter-inch inoculation scar, also omitted from the autopsy papers.

Eddowes says he's studied hundreds of confidential reports from the CIA and the FBI when they became available through the Freedom of Information Act.

"In addition, I've talked to well over 100 people connected with the case. All that is left to do is to examine the body in the grave.

"But," the British lawyer says, "if the CIA has information on Oswald's being alive, they owe it to the American people to disclose what they know."
