The uneasiness has not been helping me keep things straight.

And during this time I've had a very long affidavit to draft for an FOIA case with an openly hostile and projudiced judge, Pratt. It has taken me to this evening to read and correct. No time for even reorganization. Has to be filed by the end of the week. I have hopes for it, if not for immediately victory in this case, a JFK one. My wife is retyping it now.

If you have any Jaworski interests and if I have not put it this way there is no better choice for one to head a committee investigating laundering, clandestine money. Jaworski did if for the CIA, with other lawyers, with M.D.Anderson Fund and some of his own cash. Whemobody else would use this I gave it to Art Kevin, an old friend at KMPC radion, Los Angeles. Art was abroad when Jaworski was just appointed. I've refreshed his mind, told him about Cong. Harold Sawyer raising some questions, told him he'd find that the funnymoney Jaworski handled in Mexico for a client was the turned wheel, the client was Anderson, Clayton - Anderson Fund Anderson. But I can't find time to do what I know better than others so I've not been able to follow it. Closely, that is. My suggestion for the future on this is that you pick out one of your people to go over the financial records when I get them. They'll be purged, in some cases properly, but there will be a hell of a story in them. You could have had a scopp on this, as you now realize. I paid for those records long ago and I've had then since 6/10. Not the story accounts of "just released."
